<p>The undersigned certifies and swears that I have just and reasonable grounds to believe, and do believe that the above named Defendant committed the listed violation(s) of law. The Person taken into custody:</p> <p><input type="checkbox"/> Committed the below acts in my presence.</p> <p><input type="checkbox"/> Confessed to [WITNESS] admitting to the below facts.</p> <p><input type="checkbox"/> Was observed by [WITNESS] who told [WITNESS] that he/she saw the arrested person commit the below acts.</p> <p><input checked="" type="checkbox"/> Was found to have committed the below acts, resulting from my (described) investigation.</p> <p>On May 18th, 2026 at approximately 21:04 hours, I responded to [REDACTED] regarding a domestic disturbance.</p> <p>Upon arrival, I made contact with the complainant identified as Amanda Pacinelli, date of birth June 9, 1989. It should be noted that Amanda appeared to be extremely intoxicated and had a difficult time remaining focused.</p> <p>Amanda stated the following: she had called because the incident needed to be documented. She had recently visited a substation to pull records of prior calls where nothing had been done. She stated her daughter Kennedy Marquardt, date of birth July 13, 2016, had been watching a show and eating ice cream when the incident occurred. She stated the other party was Kennedy's father and that he was very violent. Amanda stated she came home from work and the male, who is rarely present, was at the residence. She stated they moved to the garage to talk because she didn't want to argue in front of their child. Amanda stated he pushed her down in the garage. When asked where on her body he pushed her, she stated he grabbed her arms and pushed her down, causing her knee to hit the ground. I observed blood on Amanda's left knee. Amanda stated as soon as she saw blood, she decided to call law enforcement. When asked if he hit her in the face, Amanda stated not tonight. I noted what appeared to be possible bruising on her nose, but she stated it was sunburn from being at work all day. I observed bruising on Amanda's left arm. Amanda confirmed she and Maverick Marquardt date of birth [REDACTED] have a child together. Amanda stated there were no witnesses to the incident.</p> <p>At approximately 21:36 hours, I made contact with Maverick. Maverick stated the following sworn statement: Amanda came home intoxicated and immediately became aggressive. Maverick stated he was trying leave and had been collecting his belongings. Amanda then grabbed a large piece of wood from a new bedroom set that had been in the garage for four or five days and struck him on the neck with it. Maverick stated he pushed Amanda away from him and then left the residence. Maverick stated he and</p>			

Amanda had been separated since January 2026 but were still cohabitating and trying to coparent. Maverick stated Amanda refuses to leave the house despite having a boyfriend. I observed redness and swelling on the right side of Maverick's neck. Maverick stated the security cameras in the residence were not operational because Amanda had broken them previously.

I returned to speak with Amanda and asked if she had hit Maverick with anything. Amanda stated she did not touch Maverick whatsoever and swore she never hit Maverick at all. Later, while completing my paperwork, Amanda began talking to herself about what happened.


Based on the aforementioned, I find probable cause for the arrest of Amanda Pacinelli for the following charge:

Aggravated Battery (Domestic Violence), by knowingly and intentionally striking her child's father in the neck with a piece of wood, which resulted in Maverick sustaining minor injuries, pursuant by FSS 784.045(1)(a)(1).


