I introduced myself to Kirshbaum and asked her where she was coming from. Kirshbaum stated that she was coming from dropping her friend off in Jupiter. I then asked Kirshbaum what she and her friend were doing before she dropped her friend off, and she stated that they just want to dinner. I then asked Kirshbaum if she had anything to drink tonight and she stated that she did not. While talking to Kirshbaum, I noticed that her face was flushed, she had red glassy eyes, slurred speech and she had a strong odor of an unknown alcoholic beverage coming off her breath. I asked Kirshbaum to step out the vehicle to which she complied. I asked Kirshbaum if she would be willing to complete several Standardized Field Sobriety Tasks (SFSTs) in order to dispel my suspicion of her driving under the influence of drugs and/or alcohol. Kirshbaum stated that she will not do the tasks. I advised Kirshbaum of her Taylor warnings, and made her aware that I will have to base my arrest decision based on what I have witnessed. Kirshbaum stated that she understood and still refused to do the tasks. Kirshbaum was placed under arrest for driving under the influence. Handcuffs were placed on Kirshbaum, which were checked for fit and double locked. At the time of the arrest Kirshbaum was wearing a black crop top, black leggings, and black sandals. Kirshbaum was searched by Palm Beach Gardens Police Officer Luscavich (ID# 513) before being placed in the rear of my marked patrol vehicle. Kirshbaum was transported to the PBSO breath and alcohol testing center (BAT) where she was observed for 20 minutes. During the 20 minute observation, Kirshbaum did consume or regurgitate anything.

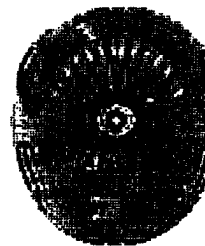

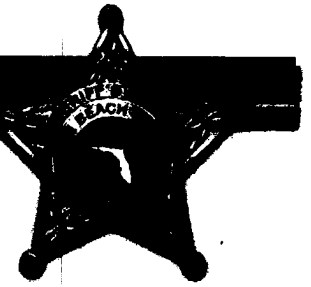
