☐ Marsy's Law CVI FL Const. Art.1 § 16(b) On April 8th, 2025, at approximately 1242 hours I was dispatched to [REDACTED] in unincorporated [REDACTED] in reference to a domestic battery. Upon arrival, i made contact with the victim, identified as Alyssa Brander, who stated she got into a domestic dispute with her mother, Amy Brander. Alyssa was visibly upset and crying. Alyssa stated Amy was angry with her due to Alyssa not being motivated to get out of bed. Alyssa advised her mother entered into her bedroom and began yelling at her to get out of bed and clean. Alyssa said Amy had a plastic package of cleaning wipes in her hand and threw the package at Alyssa as she was sitting in her bed. Alyssa stated the package struck her in the face. I observed Alyssa's lip was slightly swollen on the left side and she had a small cut on her lip as well. Alyssa stated her mother left the residence after the argument continued. A sworn statement was taken from Alyssa which was captured on my body worn camera. Photos of her injury were taken and uploaded to evidence.com. Photos were taken of the cleaning package that was thrown at Alyssa. Amy Brander was not at the residence when I arrived. I made contact with Amy over the phone and she provided a similar story. Amy stated she got into an argument with Alyssa over her lack of motivation. During the argument, Amy stated she threw a package of cleaning product at Alyssa. I met with Amy at PBSO District 4 substation, 14925 Cumberland drive, where she was placed under arrest. Amy was placed into handcuffs, they were double locked and checked for proper fit. Based on my investigation, there is probable cause to arrest Amy Brander for simple domestic battery, as she did intentionally and willfully strike her daughter Alyssa Brander in the face with a plastic container causing an injury to Alyssa's face in violation of FSS. 784.03(1a1).
