The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/20/2023 at approximately 2239 hours, a traffic crash causing property damage occurred at the intersection of Martin Luther King Jr Blvd W and Himes AV N during which a silver 2021 Lexus SUV with Florida tag QFZX55 was following too closely and struck the rear end of a black 2023 Mercedes Benz SUV with Florida tag IMTA38 causing approximately \$200 in property damage. The driver/defendant briefly exited the vehicle, made contact with the victim, advised there was no damage to his vehicle, and left the scene without providing the required information or notifying law enforcement about the traffic crash. A BOLO was placed and TPD Ofc. J. Sikoski located the vehicle at the intersection of Himes Av N and Columbus Av W. Based on the information provided in the BOLO and the fresh vehicle to the vehicle, TPD Ofc. J. Sikoski made contact with the vehicle based on reasonable suspicion it was involved in a hit and run criminal offense. TPD Ofc. J. Sikoski made contact with the driver/defendant, observed indicators of impairment, and requested a DUI investigation be conducted. I responded to the scene and made contact with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, was fumbling her documents, had difficulty focusing/answering basic questions, confirmed she had been drinking prior to driving, had a odor sway while standing outside of the vehicle, and had the odor of an alcoholic beverage coming from her breath. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. She submitted to the requested breath testing which produced a BrAC of 0.122/0.118. The victim confirmed the defendant's identification. The defendant was positively identified via DHSMV photograph.
