PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Saturday, April 5th 2025 at approximately 1733 hours, I responded to a traffic crash at 6060 Okeechobee Blvd, in unincorporated West Palm Beach, FL 33417 (Palm Beach County). Upon arrival I observed two vehicles crash in the middle lane of westbound Okeechobee Blvd at the entrance to the Florida Turnpike. A white Toyota Rav4 rear ended a white Chevrolet Tahoe. The Toyota Rav4 bearing Florida tag QLSH15 was occupied by a white Asian female, she was the sole occupant and she was in the driver seat of the vehicle. She appeared to have vomited on herself. I noticed a strong odor of an unknown alcoholic beverage emitting from her while she was inside the vehicle. She struggled to locate her driver license and had to give her name verbally. She was identified as An Jin Jung. Her identity was later confirmed by her Florida driver license located in her wallet.

OBSERVATION OF DRIVER:

I observed the defendant, An Jin Jung who was wearing a black dress and black sandals. The defendant was sitting in the driver seat and she was alone. While stepping out of the vehicle she was unsteady on her feet and stumbled. I asked the defendant to walk over to the front of my vehicle and speak with me. While walking over to my vehicle, the defendant was unsteady on her feet and staggered as she walked. While standing stationary the defendant swayed. I could see the defendants eyes were bloodshot and glossy. She had an obvious odor of an unknown alcoholic beverage emitting from her breath that grew stronger as she spoke. The defendants speech was slow and slurred.

DRIVER'S STATEMENTS:

The defendant said he did not have any physical defects or preexisting injuries, diabetes, or wear glasses, she was wearing contacts. The defendant said she had nothing to drink and then changed it to one drink, but would not tell me what it was. The defendant said she was coming from seeing a friend/coworker and going home. I asked the defendant to submit to roadside field sobriety tasks to which she agreed.

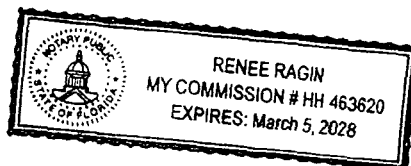

Other Observations:

The defendant swayed while standing stationary. I had to remind the defendant to not turn her head multiple times. I had to remind the defendant to follow the red light.

WALK & TURN:

I placed yellow tape in a straight line on the asphalt. The asphalt was relatively level. The task was explained and demonstrated. The defendant stated she understood the instructions. During the task the defendant failed to maintain the instructional stance by stepping off the line. The defendant swayed while standing stationary. The defendant used her arms for balance throughout the task, did not touch heel to toe multiple times, stepped off the line, stopped to regain balance, and took the incorrect number of steps. She only took 6 steps and stopped. She turned around improperly and took 6 steps again.

ONE LEG STAND:

The task was explained and demonstrated. The defendant stated she understood the instructions. The defendant swayed while standing stationary. During the task the defendant used her arms for balance, she swayed and hopped. She refused to listen to instruction and did not put her hands by her side.

FINGER TO NOSE:

The task was explained and demonstrated. The defendant stated she understood the instructions. The defendant swayed while standing stationary. During the task the defendant failed to touch the tip of her nose by only raising her head up in the air. She missed the tip of her nose by touching her face and lip area.

ROMBERG ALPHABET:

She was unsure about reciting the English alphabet. She said she could count from 1 to 26. The task was explained and demonstrated. The defendant stated she understood the instructions. The defendant swayed while standing stationary. During the task the defendant failed to keep her eyes closed and she skipped the number 15.

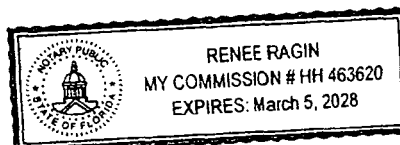
