On Friday, April 26th, 2024, at approximately 2032 hours, I responded to _____ in reference to a domestic disturbance between the complainant and his wife that was physical and involved a knife.									
Prior to our arrival, dispatch advised that the complainant, identified as Robert Cedeno _____ was trying to get away from his wife, Ana Leal Pereira 08/31/1981 after the two were in a physical altercation. Dispatch advised that a struggle appeared to be ongoing while speaking with Cedeno over the phone.									
Upon the arrival of law enforcement, Cedeno and Leal Pereira appeared to be standing in front of a neighboring residence, having a verbal argument. Attempts were made to separate the parties to gather information as to what occurred, but Leal Pereira appeared to be intoxicated and refused to follow any commands given. Because of Leal Pereira's erratic behaviors, she was detained and placed into D/S Smith's 15068 patrol vehicle.									
I then began speaking with Cedeno, who stated the following: The initial issues between himself and Leal Pereira began earlier in the evening at approximately 1700 hours after he returned home. Leal Pereira asked him to go and get her something sweet from the store, but by the time he returned home, she told him that she had bought and drank an entire bottle of Limoncello alcohol, which caused her to become intoxicated. He attempted to separate himself from her by entering their bedroom, but she entered shortly after and began arguing with her. She exited the bedroom and went to grab another alcoholic beverage, but he entered the kitchen and poured the drink down the drain before she could consume it. This caused Leal Pereira to get upset with him, and as he went back to the refrigerator to get the rest of the alcohol, Leal Pereira pushed him back before placing her hands around the front of his throat and neck. He got away from her and went back to the bedroom, but she followed him inside and proceeded to strangle him with her hands around his throat for approximately one minute, causing him to have difficulties with breathing. He was able to separate again and told her that he was going to call the police. After hearing that the police were going to be involved, he watched her walk out of the room and back into the kitchen. He retrieved a knife from the knife block in the kitchen. She did not make any threats to harm him and immediately returned the knife to the block. He attempted to exit the residence while on the phone with 911, but Leal Pereira constantly attempted to keep him from leaving by pushing and shoving him back inside. He eventually was able to exit through the front door, but Leal Pereira continued in her pushing and shoving. All activities ceased as law enforcement arrived at the residence.									
While speaking with Cedeno, I observed what appeared to be fresh bruising around the front and sides of his throat, consistent with his statement about being strangled. Cedeno also had video footage from the incident from cameras located within and on the exterior of the residence. The video showed Leal Pereira putting her hands around Cedeno's throat in the kitchen, but no footage existed of the knife in her hand. Video footage on the exterior of the residence also showed Leal Pereira pushing Cedeno back in the direction of the house while he was trying to get away from her.									
After speaking with Cedeno, I attempted to retrieve a statement from Leal Pereira, but she refused to state what occurred. She simply stated that nothing had occurred and denied that what had been observed on video surveillance had occurred.									
Based on the above information, Ana Leal Pereira is in violation of Florida Statute 784.03(1)(a)(1) Simple domestic battery and Florida Statute 784.041(2) domestic battery by strangulation.
