The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the aforementioned date, time, and location, the defendant was attempting to initiate sexual intercourse with her husband/victim who was laying down on a mattress in the bedroom, by placing her hands in the victim's pants. The victim pushed the defendant away with his foot in an attempt to separate himself from her. The defendant subsequently intentionally kicked the victim in the sternum/upper abdomen against his will.
