On 04/01/2023 at approximately 0223 hours, this Officer arrived in Northmil Plaza, 4411 Northlake Blvd, PBG, FL, to assist Ofc Johnston 451 and Ofc Koegel 456 with an investigation. Body worn camera and in car video were used. Ofc Johnston said he and Ofc Koegel were in the area of N Military Trl and Northlake Blvd, PBG, FL, when they heard a possible vehicle collision. Officers said by the time they looked in the area, they observed a Ford pick-up truck driving over the median from north bound N Military Trl into the south bound lanes while still going north bound. Officers said the vehicle then re-entered the north bound lanes then pulled into the plaza and parked. Ofc Johnston said the individual seated on the curb speaking with Ofc Rhymer 521, was the driver at the time of the incident. This Officer approached the vehicle, a Ford F150 (IJ65IE/FL) and inspected same for damage. This Officer noticed both driver side tires were flat and there was a scratch on the driver side step. This Officer then made contact with the individual sitting down, identified via Florida Driver license photo, Andre Alves Silva (OF), who appeared highly intoxicated. Silva had thick slurred mumbled speech, low droopy eyelids, red watery eyes, flushed red face, and the strong obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Silva said he was coming from work at Frigate's. This Officer asked Silva to stand up to which he complied. This Officer observed Silva to be very uneasy on his feet and when he walked, it was with an unsteady gait. Silva said he was on his way home. Silva denied consuming alcohol on this night citing he was at work. This Officer asked Silva how he ended up on the curb, to which he was unable to provide an explanation. This Officer then asked about him telling Ofc Johnston about "having a few shots", to which Silva agreed. Silva said he did not have any medical conditions which would affect Standardized Field Sobriety Exercises.

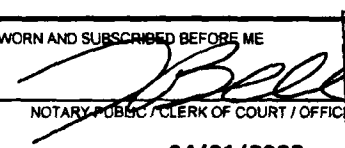
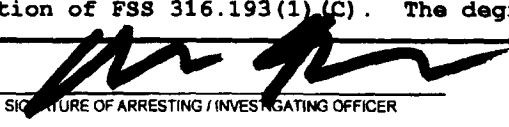

The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight with an illuminated red tip. This Officer observed a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Silva also had the onset of Nystagmus prior to 45 degrees in both eyes. Silva was orbitally swaying throughout the exercise and almost lost his balance while standing in one spot. The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Silva had great difficulty getting into and remaining in the starting position. Silva repeatedly lost his balance and took extended time to get back into the position. Silva also started prior to being told to do so multiple times. Prior to starting the exercise, this Officer ensured Silva understood, to which he said he did. During the first set of steps, Silva took four steps, then lost his balance and stumbled off the line. Silva then told this Officer to take him to jail, to which this Officer advised him of his Taylor Warnings, to which he acknowledged and agreed to continue. Silva then returned to the starting point and started again. Silva missed heel-to-toe on steps two through eight. On steps four five and six, Silva paused to regain balance. Steps four and six Silva stepped next to the line. Silva took eight steps rather than nine and was flailing his arms up and down well over six inches from his sides throughout the attempt. Silva conducted an improper turnaround by way of pivoting on both feet, rather than taking a series of small steps to turn around. During the return set of steps, Silva stepped off the line prior to taking his first step. Silva missed heel-to-toe on all nine steps and kept his arms raised more than six inches from his sides. The third exercise conducted, was the One-Leg Stand. Silva raised his right foot. This Officer instructed Silva to look at his foot. Silva hopped 10 times then placed his foot down. Silva raised his foot then hopped twice and placed his foot down again. Silva raised his foot a third time and hopped six times before placing his foot down, thus ending the exercise early. Throughout the exercise Silva swayed side-to-side and raised his arms well over six inches from his sides. Based on this Officer's observations, Silva was placed under arrest at 0238 hours. At PBSO BAT, this Officer requested Silva provide a breath sample for the purpose of determining its alcohol content to which he consented. At 0334 hours he blew .271 and at 0337 hours he blew .266. Based on the results of the investigation, this Officer has probable cause to prove Andre Alves Silva operated a motor vehicle, in the county of Palm Beach, in the state of Florida, while under the influence to the extent his normal faculties were impaired, with an unlawful breath alcohol content, in violation of FSS 316.193(1)(C).
