the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

common with, Andrew Umland (OF) and they both became intoxicated [REDACTED] said that once they returned to the above residence a verbal argument initiated between them She could not remember what the argument was in reference too, but she said that Andrew approached her and punched her with his right hand, one (1) time striking her in the chin She said that Andrew then said he was going to pick up their child from [REDACTED] middle school located at [REDACTED] and left the residence While speaking with [REDACTED] she smelled heavily of alcoholic beverage and was slurring her words [REDACTED] sustained a laceration to the bottom of her chin, and I did not observe any other apparent injuries on her [REDACTED] signed a sworn affidavit in favor of prosecution [REDACTED] refused to provide me with a sworn digitally recorded statement
