On 08/02/2024, at 21:58 hours, I was at the Hilton Hotel located at _____ when a representative from the hotel approached me. Simeon Storr advised me that they had issues with a belligerent white male. At the front lobby, I observed a white male using the desk holding himself up. When speaking with Simeon, he informed me that he had been attempting to reach Andrew all day to settle his bill, but Andrew had been evading him. Simeon further revealed that he managed to locate Andrew in the bar area, where he was causing disturbances and making inappropriate remarks to the female staff. As the situation unfolded, it became increasingly clear that Andrew was not only refusing to settle his bill and vacate the premises but also becoming more aggressive and uncooperative, even failing to follow simple instructions. Contact was made with the male, who was identified as Andrew Priestman. Andrew was advised that he is no longer allowed to stay in the hotel due to the issues he has been having with the hotel. Due to Andrew's current state of being under the influence of an unknown alcoholic beverage, he was told numerous times why he was being trespassed from the property. Andrew did not listen and continued to state to officers at the scene, "I'm rich; I have money; I can pay," nonetheless, Andrew was seen opening and closing his text app and not addressing the issue of paying his leftover amount of \$542.86 before he is trespassed and no longer able to come back to the hotel. Andrew was given time to pay his tab and leave the property, but Andrew continued to

avoid paying his bill and kept telling officers and hotel representatives that he was "Rich" and could pay. I explained to Andrew that was not the issue at hand. Due to what Andrew's loud and belligerent behavior it was causing people to stop what they were doing to see what was going on with Andrew. Andrew's behavior was escalating and disturbing the peace and safety of the public at the hotel. Additionally, he has refused to comply with the orders he was given regarding being trespassed. As a result, he was arrested under the following Florida State statute: 1) F.S.S: 856.011 - Disorderly Conduct - Disorderly Intoxication 2) F.S.S: 810.09(2) (B) - Trespass After Warning - Property Andrew was taken to the Riviera Beach Police Department for processing and then to the Palm Beach County Jail without further issues. Andrew's wife responded to 3700 N Ocean to pay Andrew's outstanding balance, therefore, so he was not charged with defrauding an innkeeper. NOTE: Before taken to Palm Beach County Jail, Andrew attempted to intimidate me (Officer Murphy) by advising that he could cause issues for me and implied that he could get someone to "go after me and my family." Andrew also stated while in the Riviera Beach jail cell that I (Officer Murphy) was a "monkey" numerous times and said that I was a "Niggro" who did not know what he was doing. It will be documented on a body-worn camera and uploaded for documentation.
