☒ Marsy's Law CVI FL Const. Art.1 § 16(b) On Thursday, February 1, 2024, at approximately 2052 hours, I responded to [REDACTED], [REDACTED] about a domestic battery. Upon arrival I spoke to Andrew Lott who advised that his ex-girlfriend for ten months who was later identified as Jaime Lecky, ended their relationship one week prior today, and she arrived at his residence to pick up some belongings. While speaking to Mr. Lott, Ms. Lecky stopped two blocks away and dialed 911 to report that her ex-boyfriend for ten months and resided together had hit her. Ms. Lecky advised that she arrived at Mr. Lott's resident to pick up some personal items, however Mr. Lott did not want her at the residence at the time. Ms. Lecky stated that while she was at the front door to enter the residence to get her belongings, Mr. Lott intentionally grabbed Ms. Lecky by the throat and pushed her out of the residence, which caused her to fall down three steps. Ms. Lecky refused treatment from fire rescue, however she wished to prosecute at this time. Ms. Lecky willingly provided a recorded sworn statement that I uploaded to Evidence.com. I observed mild redness around Ms. Lecky's neck that I also captured photos of ad uploaded it to evidence.com. I detained Mr. Lott, handcuffed him to the rear with proper fitting, double locked, and laced him in the backseat of my green and white PBSO marked unit and transported him to county jail without incident.
