I § 16(b) On Monday, November 13, 2023, at 1607 hours, I was dispatched to 5986 Glendale Drive, located in Unincorporated Boca Raton within Palm Beach County, Florida, 33433, in reference to a domestic battery in progress. I made contact with Aron Fried (victim) at the above location. Victim came outside his residence, at which time I observed his left eye had a laceration. Palm Beach Fire Rescue Engine 51 made contact with Aron under run alarm #23134336, and he was told to put an ice pack on his left eye. He advised that Anie Restrepo (Defendant & ex-girlfriend) had been together for five (5) years and lived at his residence. Victim told me that he and Defendant separated two (2) months ago, and he had her evicted on Tuesday, October 3, 2023. Victim said that Defendant came to his residence to get money from him to pay for her 2023 Lexus vehicle's bodywork repair. Victim let the Defendant come into his residence. Victim said that Defendant wanted \$2000 to repair her vehicle, but he told her that he did not have it. Victim told me that the Defendant began getting very angry, at which time he was trying to calm her down. Victim told Defendant that I did not have any obligation to take care of your responsibilities since we are not together anymore. Victim said that Defendant began arguing with him in the kitchen and asking him about his new girlfriend. Victim said his girlfriend was not home at the time. Defendant decided to walk upstairs to Victim's bedroom to confront his girlfriend, who is now living with him. Victim said Defendant walked back downstairs to the kitchen. Victim said that Defendant punched him twice, with her right-hand fist on his right shoulder. Victim then walked Defendant out of his residence and attempted to close the front door. Victim advised that Defendant pushed the front door open and hit him on the left eye with her iPhone 14, which was on her right hand, causing a laceration.

☐ Marsy's Law CVI FL. Const. Art. 1 § 16(b) Victim told Defendant that he was going to call the police, at which time she got inside her 2023 Lexus vehicle and drove off in an unknown direction. He called Shira Harir (daughter) via landline and told her that Defendant physically attacked him. Shira called the police to respond for Victim's safety. I asked Victim if he had Defendant's new home address, to which he replied "no". A record check revealed that Defendant still has 5986 Glendale Drive, Boca Raton, Florida 33433 on her Florida Driver's License. Defendant provided me with a sworn written statement on this incident. On Tuesday, November 14, 2023, at 1551 hours, the Defendant responded to P.B.S.O. District 7 to give her side of the story. Deputy P. Armentero (Id 39057) was present due to the Spanish translation. Defendant was read Miranda Rights, at which time she signed and date. The Defendant told me and Deputy P. Armentero that she came to the Victim's residence to show him the repair bill for her vehicle. Defendant said that the Victim called her to come to his residence to show the bill. Defendant said she knocked on the front door, at which time the Victim let her inside the residence. Once inside, the Defendant showed the Victim the bill, at which time a verbal argument started. The Defendant told me and Deputy P. Armentero that the argument became physical after the Victim saw the repair bill for her vehicle. The Defendant said that the Victim grabbed her from her right bicep with his left hand, at which time the Defendant hit the Victim with her cell phone on his left eye, from her left hand. Defendant said she then got inside her vehicle and left the premises in an unknown direction. Based on my investigation, it was determined that the Defendant hit the Victim in the left eye with her cell phone. Therefore, probable cause exists to arrest the Defendant for simple battery.
