NARRATIVE:

On Tuesday, April 9, 2024, I was assigned to North Region Patrol Operations. At or around 1844 hours, I responded to the area of Okeechobee Blvd and Skees Road where I met with W/F Tiffany Imbesi (7/6/2005).

Tiffany requested Deputies respond with her to

to remove her personal belongings from her mother's residence.

Moments later, we arrived at the aforementioned address and the home of W/F Anita Imbesi (12/31/1970). As Tiffany entered, she informed Anita that was she was there gather her belongings in peace. I informed Anita that the Sheriff's Office was present just maintain the peace amongst the two. Anita acknowledge us and said it was not a problem. Within seconds of being inside, the two began to argue with another referencing a previous argument in which Anita attempted to kick Tiffany out of the home. The two continue argue back and forth for the several minutes, referring to Tiffany's father, which is Anita's ex-husband, Anita's son, and Anita's mental health (physiatrist/ therapist) and accountability from one another.

During the course of the argument, Tiffany informs Anita that she does not want to live there any longer as she is gathering her personal items. Anita attempts to tell Tiffany that she wants her to remain living there, turning towards my direction for approval. I informed Anita that Tiffany was an adult and this was the reason Tiffany requested Law Enforcement presence. Anita stated that this was "new" stuff to her and the two had been getting along just fine.

For the next several minutes, the two continue to yell at one another as Tiffany tells Anita that she just wants to be left alone and wants space. Tiffany continued telling Anita she just wants her space to be left alone. Anita request to speak with Tiffany one more time and the following is learned and spontaneously uttered between the two.

Tiffany: "No because I tried talking to you today and you know what you did? You screamed at me! You started fucking hitting me and shit, no!"

Anita:" I didn't hit you. I just hit your arm. Tiffany, don't because you were freaking out."

NARRATIVE CONTINUATION

As two continued to argue, I requested Anita allow Tiffany to finish gathering her belongs and the two can speak at a later date and time. Without being interrupted, Tiffany concluded gathering her items and we departed the house.

Moment later, I met with Tiffany to conduct a sworn recorded interview based on the comments that were made in my presence during course of her gathering her items. The following is brief synopsis, for an accurate and verbatim account please see body worn camera (BWC) footage.

I asked Tiffany what occurred earlier in the day and she stated the following:

"We were driving together in the car and I was driving and she was in the passenger seat, and we were arguing back and forth about the same that we always argue about. And she started to get aggressive with me what's, what's like, she started screaming louder and shit was spitting in my face and she was getting in my face when I was driving and she was hitting my right arm while I was driving. And it was making the steering wheel like turn, so I had pull over really fast. And I pulled over so fast it apparently alerted life360 that I crashed, but I pulled over really fast"

I inquired if anyone else may have been alerted to the crash notification, which Tiffany informed it also went to her friend Ariana. Tiffany continued and said that she pulled over and she told Anita to get out of the car because Anita was hitting her as she was driving and that she felt she was going to crash. I asked Tiffany how many times Anita punched her she said "like 5 times in times in my right arm and then she pointed to her left wrist where she said Anita scratched her as she was attempting to get her off of her. There was minor redness still visible.

While speaking with Tiffany, she revealed during the course of the argument with Anita, she activated her phone in attempts to record the altercation. Tiffany shared the video with me, which reflected: Tuesday April 9, 2024 12:02PM and mapping location of Okeechobee Boulevard / Crestwood Boulevard.

The video recording from Tiffany's phone depicted her keeping her phone camera faced down, to not allow Anita to be aware she was being recorded. You can hear Tiffany say, "you just hit me, you just hit me." Anita can be heard attempting over talk her and say "acknowledge what im saying." Tiffany starts frantically screaming/crying "you just fuckin hit me' get out, get out."

Tiffany further provided me with a screenshot from her phone that read: Today 12:11 PM "Life360 detected sudden motion on Tiffany's phone. This could be result of a collision, hard braking or a dropped phone. We suggest you call Tiffany to check on them. Then list her phone number.

Based upon the aforementioned investigation, this evidence (video evidence , screen shots, statements and spontaneous utterances/own admission) highlights and illustrates what transpired between Anita Imbesi and Tiffany Imbesi on todays date . I find probable cause exist to charge Anita Imbesi with Battery (Domestic) pursuant to F.S.S. 784.03 (1)(a)(1).
