On the 13 day of January, 2023 at 01:18 (Specifically include facts constituting cause for arrest.) On 01/13/2023 at approximately 0118 hours, this Officer arrived in the area of Garden Square Blvd and PGA Blvd, PBG, FL, to assist Ofc Hennessy 409 on a traffic stop. Body worn camera and in car video were used. Ofc Hennessy said he observed the vehicle, a Mercedes utility vehicle (KUST23/FL) in the area of PGA Blvd and Interstate 95, PBG, FL, traveling 60 MPH in a posted 45 MPH zone. Ofc Hennessy further stated the vehicle also stopped beyond the stop bar at the intersection of N Military Trl. Ofc Hennessy conducted a traffic stop on the vehicle at the location. This Officer made contact with the driver and sole occupant, identified via Florida Driver License photo, Anna Gilbert (OF), while she was still in actual physical control of same. Gilbert exhibited signs of intoxication including: flushed red face, slurred speech, red watery eyes, and the strong odor of an unknown alcoholic beverage emanating from her breath at conversational distance. Gilbert provided a vehicle insurance card, a vehicle service receipt, an application for a title, and an expired insurance card. Gilbert then provided an expired vehicle registration. Gilbert claimed to be coming from her house. Gilbert indicated she was having a mental break and was on her way to her boyfriend's house. This Officer requested Gilbert to exit the vehicle to ensure she was not under the influence, to which she refused claiming "I'm not allowed to". Ofc Hennessy also ordered Gilbert out of the vehicle to which she also claimed "I'm not allowed to at this point, my dad is a lawyer". Gilbert then said "he's a piece of shit, he's probably wrong". Gilbert was told more than seven times to exit the vehicle, before this Officer assisted Gilbert in exiting the vehicle, without using force. Gilbert said she did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight with an illuminated red tip. During the exercise, Gilbert began to

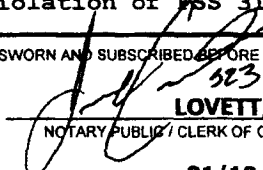

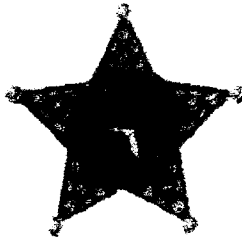

cry and then sat on the ground. Gilbert then layed on the pavement while still crying. Officers offered to call Fire Rescue three times, to which Gilbert refused medical attention. This episode lasted for approximately four minutes before the exercise was continued. This Officer observed a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Gilbert also had the onset of Nystagmus prior to 45 degrees in both eyes. The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Gilbert stepped out of the starting position and raised her arms from her sides. During the first set of steps, Gilbert stopped after her ninth step and looked at this Officer. Gilbert was asked if she remembered instructions and was told to continue. Gilbert conducted an improper turnaround by way of pivoting on both feet. During the return set of steps, Gilbert missed heel-to-toe three times and raised her hands more than six inches from her sides. The third exercise to be conducted, was the One-Leg Stand. Gilbert again began to cry and not get into the instruction position. This lasted for approximately five minutes. This Officer explained the exercise then Gilbert demanded the instructions again. Rather than explaining again, this Officer demonstrated the exercise for Gilbert. Gilbert then demanded this Officer start over. Gilbert then said "I'm not doing that", Gilbert then attempted to walk back to her vehicle. Gilbert was immediately placed under arrest at 0140 hours. While in the rear of this Officer's vehicle Gilbert cried and screamed demanding to be driven by Ofc Luscavich 513. This Officer explained to Gilbert such request was not possible. While en route to the PBSO BAT, less than 10 minutes into the ride, Gilbert was suddenly calm and fell asleep. Henceforth Gilbert no longer displayed the same emotion nor mood swings that she displayed during the initial stages of the investigation. At PBSO BAT, this Officer requested Gilbert provide a breath sample for the purpose of determining its alcohol content, to which she immediately refused. This Officer read Florida Implied Consent to Gilbert, twice to which she claimed to not understand. This Officer explained same to Gilbert to which she said she needed to call someone because other people make her decisions for her. Gilbert also indicated she was not mentally competent. When this Officer again asked Gilbert to provide a breath sample, she remained silent. This silence was eventually taken as a refusal at 0239 hours. Based on the results of the investigation, this Officer has probable cause to prove Anna Gilbert operated a motor vehicle, in the county of Palm Beach, in the state of Florida, while under the influence to the extent her normal faculties were impaired, in violation of PSS 316.193(1) (A).
