The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On Saturday, October 25, 2025, at approximately 01:29 hours, while on patrol in the 900 block of S. Ocean Blvd., within the jurisdiction of the Town of Manalapan, Palm Beach County, Florida, I, Officer Cardarelli, observed a white 2018 Chevrolet Cruze (FL tag YS1MYE) traveling northbound toward my fully marked patrol vehicle at a high rate of speed. Based on my visual estimation, the vehicle was traveling approximately 45 mph in a posted 35 mph zone.

As I got behind the vehicle, I observed that the registration was displaying expired as of June 2025. While maintaining visual contact and running the vehicle through Manalapan Main Air, I observed the vehicle's left tires consistently drifting onto and driving on the center double solid yellow lines, striking and crossing over the line, and hitting the lane reflectors multiple times. A traffic stop was conducted, and I made contact with the driver, later identified as Araceli Bravo Lopez. Upon contact, I observed that Lopez's eyes were bloodshot and watery, her speech was slightly slurred, and I detected the odor of an unknown alcoholic beverage emitting from the vehicle's interior. Based on these observations, I suspected Lopez was operating her vehicle while impaired.

Lopez admitted to consuming approximately three alcoholic beverages earlier in the evening, one as recently as 45 minutes prior to driving home to West Palm Beach from a restaurant in Fort Lauderdale. When asked to rate her level of intoxication on a scale from 1 to 10, with 1 being completely sober and 10 being drunk, Lopez stated she was at a "7." She also repeatedly requested that I allow her to call an Uber instead of continuing with the investigation. Based on my continued observations and the defendant's statements, I requested Lopez to submit to standardized field sobriety tests (SFSTs). Lopez agreed but performed the exercises poorly, displaying multiple clues of impairment on each test, including loss of balance, inability to follow instructions as given, etc.




Based on the totality of circumstances, I determined that Lopez was operating a motor vehicle while under the influence of alcoholic beverages to the extent that her normal faculties were impaired. Lopez was placed under arrest for Driving Under the Influence (DUI), in violation of Florida State Statute 316.193. Criminal UTC for DUI and expired registration were issued to Lopez.

Lopez was transported to the Manalapan Police Department, where she refused to provide a breath sample after Implied Consent was read to her at 0252 hours.

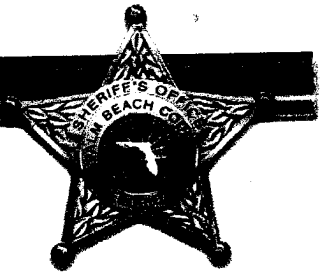
