On the **13** day of **May**, **2023** at **04:52** (Specifically include facts constituting cause for arrest.)

On May 12, 2023, at 0055hrs., I responded to 108 Santiago Dr., Jupiter, FL 33458 in reference to a noise disturbance complaint. Upon arrival, I observed several minors standing in front of the residence who appeared to be intoxicated. They were unsteady on their feet, and a strong odor of alcoholic beverage emanated from their persons. They were asked their age and responded they were 18 years old. Some rapidly fled the area on foot and others were being picked up by vehicles that were arriving as I arrived. As I walked toward the front porch, I was able to hear people shouting and electronic music playing at high volume from the interior of the residence.

I knocked at the door and a young Asian female opened the door. I asked who the owner of the property was as another Asian female approached the door. She was later identified as Ariel Nichole Lyden W/F 10/12/2004, who said that it was her house. She informed me that her parents were in Georgia. As I looked inside the home, I observed several subjects who appeared to be minors. I asked them how old they were, to which their replies were between 17 and 18 years old. There were red plastic cups and beer cans scattered on the floor and on top of the tables. I also saw blood stains on the ceramic floor.

As we were speaking with Lyden, several other individuals were observed fleeing through the backyard. We conducted an interior safety check of the residence and found several other heavily intoxicated minors locked in bedrooms and bathrooms.

Based on Lyden advising she was the adult in control of the residence, there were minors consuming alcohol on the premise, and she made no attempt to terminate the party, I find probable cause exists to arrest Lyden because she did willfully have control of a residence and allow an open house party to take place at the residence where any alcoholic beverage or drug was possessed or consumed at the residence by any minor and Lyden knew that an alcoholic beverage or drug was in the possession of or being consumed
