

E. Fritz stated she was having an argument with her sister, Megan Fritz W/F 3-24-2003, about taking her vehicle on a road trip. E. Fritz stated her sister M. Fritz hit her in her upper right arm while she was driving her family back from the Moose Lodge. I did not observe any physical evidence or injuries on E. Fritz's arm, and no one else I spoke with stated they witnessed M. Fritz strike E. Fritz.

I then spoke with Hailey Fritz W/F 11-21-1998. She was extremely and obviously upset and crying. She explained, while in the house, her sister M. Fritz was getting upset at E. Fritz about taking her vehicle on a trip. The argument began to escalate and H. Fritz said she felt defensive for her sister E. Fritz since she was the older sister. H. Fritz then stood up and she and M. Fritz began to yell at each other. H. Fritz said she did not make any aggressive posture towards M. Fritz, when suddenly her father, A. Fritz came up behind her and put his arm around her neck/throat area. H. Fritz said she was unable to breathe while his arm was wrapped around her neck. Due to this, H. Fritz attempted to pull and scratch A. Fritz's arm in order to get it off her throat. I noticed a small amount of dried blood under H. Fritz's fingernails and on her throat. Photo's were taken and later uploaded to evidence.com.

I spoke with M. Fritz. She was angry and yelling at me while I attempted to speak with her. She stated her sister E. Fritz got upset because she wanted to leave the house. M. Fritz then admitted to getting into an argument with E. Fritz about taking her car on a road trip. She then stated h. Fritz was still getting upset and began to slam the doors in the home and she recorded it. M. Fritz showed me her cellphone, but I only observed/heard a verbal argument. M. Fritz denied hitting her sister E. Fritz in the car as well.

I spoke with Arthur Fritz. I asked him what occurred and he said his daughters were in an argument, but would not elaborate. I again asked what occurred, then he said, H. Fritz was arguing with M. Fritz and he thought it might get physical, she he then grabbed H. Fritz from behind, but again would not give details. I observed fresh scratches to his left lower arm with dried blood and bandages.

Due to the above statements and injuries, I find probable cause to charge A. Fritz with Domestic Battery by Strangulation. I transported him to Jupiter Medical Center for clearance, then to the PBCJ with out incident.
