The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 08-31-25 at approximately 0250 hrs, Ofc J Legg was on foot patrol near MacDintons Irish Pub (located at 405 S Howard Ave) when he observed a grey Ford Mustang Convertible driving through the parking lot recklessly. The defendant (sole occupant of the vehicle) then stopped the vehicle, exited, and began arguing with bar security. The defendant then reentered the vehicle and attempted to leave the parking lot of the business, at which time Ofc Legg was able to make contact with defendant at which time he observed the defendant to display multiple indicators of impairment, and requested the affiant to respond to the scene.

Upon my arrival, I observed the defendant to have bloodshot/watery eyes, unsteadiness on his feet, slurred speech, and the distinct odor of an alcoholic beverage emitting from his breath. The defendant participated in SFSE's and exhibited numerous indicators of impairment. Upon arrival to the BAT, the defendant willingly provided to breath samples measuring 0.186 and 0.204 BrAC.

The defendant was ID'd via Turkish DL.
