<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On Friday May 26th, 2023, I, Officer Malachi Wilkins of the Florida Fish and Wildlife Conservation Commission was on state water patrol in Hillsborough County, Florida. At about 1535 hours I was accompanied by Dep. Justin Pass with the Hillsborough County Sheriff's Office Marine Unit near Williams Park Boat Ramp. I observed a blue vessel being operated by the defendant and who was the sole occupant on that vessel. We activated the emergency lights on our vessel and stopped the defendant for the purpose of vessel safety inspection. During the inspection I observed numerous empty alcohol cans near the back of the boat. I smelled the strong odor of an alcoholic beverage coming from his breath as he spoke to me. When asked how much alcohol he had the defendant stated he had a few. I then asked him if he would consent to performing field sobriety tasks to which he complied. The defendant performed poorly and was placed under arrest for boating under the influence. The defendant refused to provide a sample of his breath to determine its alcohol content.</p>
