On the 30 day of March, 2023 at 23:14 (Specifically include facts constituting cause for arrest.)


On 03/30/2023 at approximately 2314 hours, Officers were dispatched a to vehicle versus tree collision in the area of the 3900-block of Gardens Pkwy, PBG, FL. Body worn camera and in car video were used upon arrival.

Ofc Lovett 523 arrived on scene at approximately 2318 hours and observed a lone individual standing next to the driver side of the vehicle. The individual was later identified via Florida Driver License photo, Austin Nassir-Hessaraki (OF), the registered owner of the vehicle, a Ford Mustang convertable (QHMD24/FL). This Officer arrived and inspected the vehicle then the path it had taken from First Harmful Event to Final Rest. This Officer observed a dark, fresh tire skid mark on the raised concrete curb and a second fresh tire skid mark approximately six feet west of the first. The second mark had gouged the curb which was noted with fresh damage. The vehicle then traveled along the grassy shoulder, damaging same before striking two standing King Palm trees. The vehicle then returned to the outside lane where it remained disabled, with heavy front passenger side damage and airbags deployed. This Officer noticed the driver seat belt was locked out and the passenger seat belt was locked in. This Officer spoke with Nassir who stated he was "just a dumbass going too fast" and that he was dropping his girlfriend off at home then was on his way home. Nassir further mentioned "my tires need to be replaced". Nassir said he was the lone occupant of the vehicle and declined Fire Rescue attention. This Officer noticed Nassir to have red watery eyes, low slurred speech and at times, appeared to be stumbling while walking around his vehicle. This Officer was also able to detect the obvious odor of an unknown alcoholic beverage emanating from Nassir's breath at conversational distance. Based on Nassir's statements, the fact he was the registered owner and Officer's swift response to the call for service, while noticing no one else in the remote area of the collision, this Officer determined Nassir was the driver at the time of the collision. It should be noted, this Officer noticed no evidence of anyone occupying the passenger seat at the time of the collision.

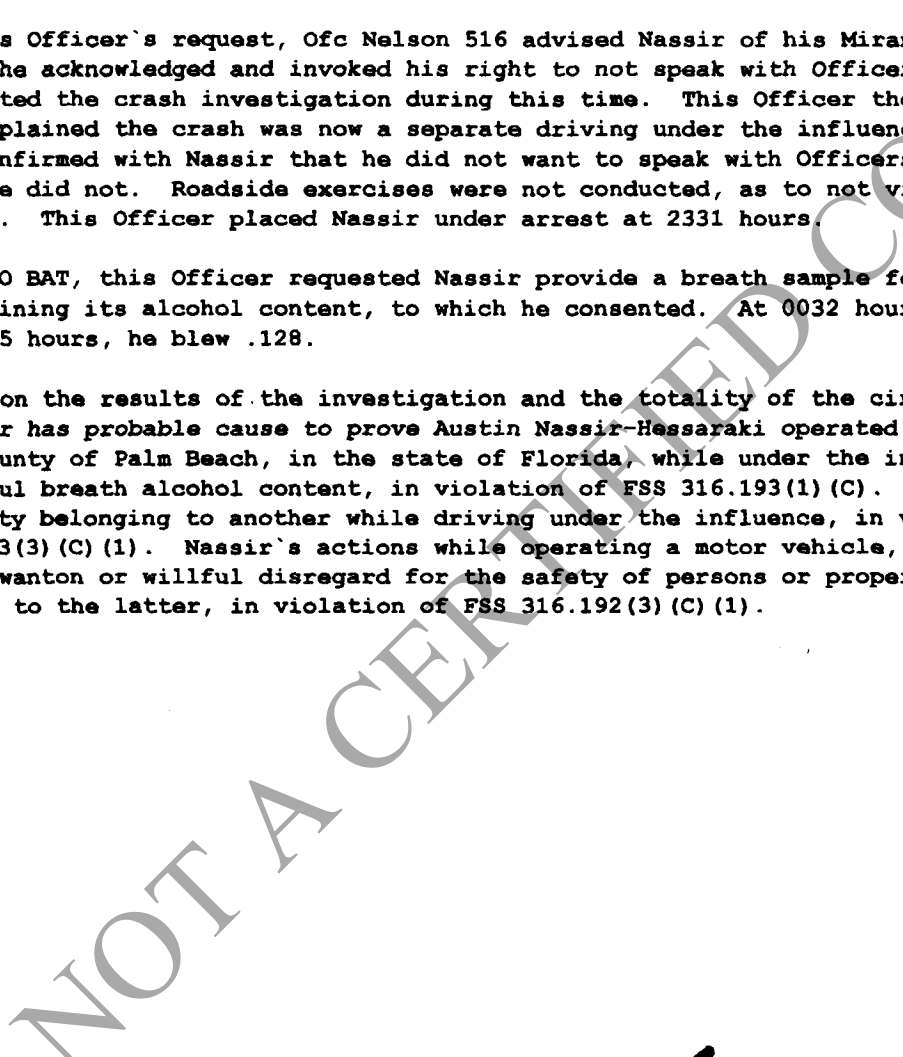

The roadway in which this occurred was a "S curve" where the roadway beared to the right, then to the left. The collision occurred between the two curves. This Officer determined the vehicle must have been traveling well above the posted speed limit of 35 MPH before it failed to negotiate the second curve. The grass and trees damaged all belonged to the City of Palm Beach Gardens (VI).

At this Officer's request, Ofc Nelson 516 advised Nassir of his Miranda Warnings, to which he acknowledged and invoked his right to not speak with Officers. This Officer completed the crash investigation during this time. This Officer then approached Nassir and explained the crash was now a separate driving under the influence investigation and confirmed with Nassir that he did not want to speak with Officers, to which Nassir said he did not. Roadside exercises were not conducted, as to not violate Nassir's Rights. This Officer placed Nassir under arrest at 2331 hours.

At PBSO BAT, this Officer requested Nassir provide a breath sample for the purpose of determining its alcohol content, to which he consented. At 0032 hours, he blew .131 and at 0035 hours, he blew .128.

Based on the results of the investigation and the totality of the circumstances, this Officer has probable cause to prove Austin Nassir-Hessaraki operated a motor vehicle, in the county of Palm Beach, in the state of Florida, while under the influence with an unlawful breath alcohol content, in violation of FSS 316.193(1)(C). Nassir damaged property belonging to another while driving under the influence, in violation of FSS 316.193(3)(C)(1). Nassir's actions while operating a motor vehicle, were done with a clear wanton or willful disregard for the safety of persons or property, while causing damage to the latter, in violation of FSS 316.192(3)(C)(1).
