<p>On 07/11/2023 at approximately 1712 hours, I responded to [REDACTED] in reference to aggressive door to door solicitors.</p> <p>Prior to arrival, I was advised that there had been multiple separate callers regarding the male subjects wearing T-shirts with the company "Lumio" repeatedly coming to their store selling solar panels.</p> <p>Upon arrival, I located 2 male subjects, identified by FL DLs as Austin Vankrevelen and Daulton Gill, wearing Lumio shirts. They stated they were only providing informational services for solar panels, not actually selling them. Further, they advised me that they were not "soliciting prostitution" therefore they had not actually soliciting.</p> <p>Deputies made contact with a resident of the neighborhood, [REDACTED] who stated the following in a sworn taped statement (summary, not verbatim): The male subjects from Lumio came to her house ringing her doorbell multiple times. She has a sign that says "no trespassing" and "no solicitation" serving as a warning to the public to not knock on her door for sales. She then told the subjects to leave her property and they refused, still trying to sell her the solar panels. She wished to prosecute for them not leaving her property when told to do so by the homeowner.</p> <p>Deputies made contact with 3 other neighbors who did not wish to be named in the report who stated that the Lumio salesmen knocked on their doors or rang their doorbells multiple times (3-6 times each) and were incessant about selling solar panels, even when the residents already had solar panels.</p> <p>Based on my investigation, I determined that probable cause exists to charge Austin Vankrevelen with: Trespassing for remaining on the victim [REDACTED] property after being warned to leave, pursuant to FSS 810.08(2)(B).</p>
