The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 Officer Taboada observed the defendant operating a 2019 Audi bearing Ohio Tag KGA8740 southbound in the northbound lanes of Nuccio Parkway at E Palm Ave into oncoming traffic. The defendant was weaving within her lane and upon being stopped came to an abrupt stop striking the curb with her vehicle. Officer Taboada made contact with the defendant who was the driver of the vehicle. Upon contact he noted the defendant to have glassy eyes, a slow demeanor, a wristband, a difficult time completing divided attention task, and a sleepy appearance. Officer Taboada requested your affiant respond to conduct a DUI investigation. Upon your affiant's arrival contact was made with the defendant who was requested to exit the vehicle. During your affiant's contact, the defendant was observed to have the odor of an alcoholic beverage emitting from her breath as she spoke, a wristband indicative of visiting a club, a constant sway to her person, watery glassy eyes, and slurred speech. Your affiant requested the defendant perform Field Sobriety Exercises (FSEs) to which she agreed. During FSEs the defendant displayed additional indicators of impairment before being placed under arrest. The defendant was transported to Central Breath Testing (CBT) where she was read implied consent. The defendant stated she was unsure if she wished to provide a lawful breath sample. Your affiant explained to the defendant she would be provided the opportunity to provide a lawful breath sample and her not doing so would be deemed as a refusal. Following the 20-minute observation period, the defendant did not provide a breath sample and allowed the instrument to time out resulting in no sample provided.

The defendant was identified via Ohio Driver's License.
