The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving a blue 2024 Ford SUV bearing Florida license plate RATZ79. He was traveling west on Kennedy Blvd between MacDill and Dale Mabry and was speeding 53 MPH in a posted 40 MPH zone, weaving back and forth, and made a last second lane change from the right lane to the left turn lane when approaching Dale Mabry Hwy. Then, while south on Dale Mabry Hwy, the vehicle made a sudden u-turn, driving over a raised cement median. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include watery and bloodshot eyes, slurred speech, flushed face, unsteady stance when he stood up from the vehicle, an odor of an alcoholic beverage on his breath, difficulties following directions, and an admission to consuming alcohol (two shots of tequila). The defendant refused to perform the SFSEs. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his Ontario, Canada DL.
