The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 10 day of August, 2023 at 00:22 (Specifically include facts constituting cause for arrest.)

On Wednesday August 9th, 2023 at approximately 2133 hours, I responded to the Starbucks parking lot (2770 West Indiantown Road), in reference to a traffic stop conducted by Sergeant Borrows on a careless driver.

Upon arrival, I made contact with Sergeant Borrows who advised me that he observed the black Infiniti that he pulled over traveling 70MPH in a posted 50MPH zone and almost rear-end another vehicle. The black Infiniti (bearing FL Tag#IPIC42), was being operated by the registered owner and sole occupant, Benjamin Herd (W/M 06/13/1974). Sergeant Borrows stated that in his brief interaction with Herd, he observed that he had a dazed appearance, droopy eyelids, heavily slurred speech, and the odor of an unknown alcoholic beverage emanating from within the vehicle. Sergeant Borrows also advised me that Herd admitted to having had two drinks earlier tonight.

I made contact with Herd who was still sitting in the driver's seat of his vehicle, which was crookedly and not completely pulled into the parking space. I introduced myself and asked Herd if he had any weapons in the vehicle, to which he stated that he did have his firearm in the center console area and a knife in his pocket. I asked Herd to exit the vehicle and removed the knife from his pocket and placed it back inside the vehicle before conducting a safety pat-down to make sure Herd did not have any other weapons on his person. I advised Herd that I was the DUI/Traffic enforcement officer on the shift and was called to the traffic stop in reference to his careless driving by almost causing an accident and his aforementioned signs of impairment. While speaking with Herd, I observed that he had bloodshot/glassy eyes, slurred speech, and the odor of an unknown alcoholic beverage emanating from his breath that intensified as he spoke. Herd admitted that he had two "cocktails" at the Elks Lodge, however, was just trying to get home. Herd stated that he had anxiety due to a women who was calling him multiple times and was not paying attention, which is why he was driving carelessly.

Based on the aforementioned events, I requested Herd submit to Standardized Field Sobriety Tasks. He immediately refused and I advised him that I was concerned for his ability to safely operate a motor vehicle and wished to have him participate so that I may get a further indication of his level of impairment. Herd still refused and was advised that if he refused to complete the tasks I have requested of him, it can and will be used against him in a court of law and I would have to make an arrest decision on the totality of the circumstances. Herd had slowed and slurred responses to my questions, however, mumbled sometime to the regard of getting an attorney and would not submit to the tasks.

Based on my investigation, observations, and totality of circumstances, I had probable cause to believe that Benjamin Herd was in actual physical control of a vehicle while under the influence of an alcoholic beverage, chemical, or controlled substance, to the point where his normal faculties were impaired, contrary to F.S. 316.193. He was placed into handcuffs that were properly spaced and double-locked per department policy and placed into the rear of my patrol car at 2147 hours.

While transporting Herd to the Palm Beach County Breath Alcohol Testing center, he would go through random mood swings of being insulting/angry or calm, telling me that he pays for my salary and hope I enjoy making no money and arresting sober people. After arriving at 2216 hours, I placed Herd under a 20 minute observation period, during which he neither consumed nor regurgitated anything. We then went on video with BAT technician Ragin#16877. Before this moment, Herd had no issue hearing or responding to any of my questions or statements during the entire investigation. I read off of the pre-printed template stating the required information and asked Herd to state his name, age, address, etc. I spoke in a firm, loud, clear, and concise manner, however, Herd ignored every question I asked him and looked around the room. I requested Herd provide a breath sample to which he still remained silent. I then read him implied consent from a pre-printed template. Herd still acted as if I was not talking and refused to answer my questions or even acknowledge my presence. I took Herds refusal to answer my questions or acknowledge my presence as a refusal. After BAT technician Ragin#16877 called the refusal time, Herd spoke up and said "are you talking to me", as if the last nearly 3-5 minutes of me speaking was to someone else. I attempted to re-explain things to Herd, who claimed he could not hear me, however, he continued to act as if he didn't not understand anything and had another angry mood swing stating that this arrest was "fucking stupid". Refusal time was marked at 2242hours.

I placed Herd in holding while all necessary paperwork was completed. Herd refused to listen to me when I attempted to explain his court date and suspension, stating he would not sign anything or listen to me. Herd was charged with Refusal to Sign/Accept pursuant to F.S.S. 318.14(3). Herd was subsequently booked him into the Palm Beach County Jail and was given a criminal court date of 09/13/2023, 0830 hours.




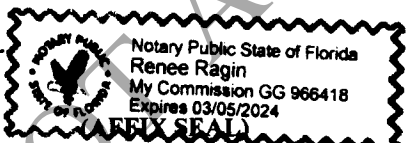
