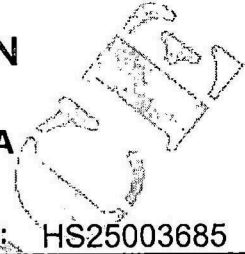

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the above listed date and time, the victim and the defendant were in a verbal altercation while driving home from St. Petersburg. The altercation escalated when the defendant knowingly, intentionally, and against the will of the victim struck the defendant in the face approximately ten times while the victim was driving. The defendant also bit the victim in the right hand between the victim's thumb and pointer finger. The victim sustained a small visible laceration to their upper lip as well as her lower lip as a result of the defendant's actions. The victim also had bruising and teeth indentations on her right hand, between the thumb and pointer finger, as a result of the defendant's actions. The victim and the defendant [REDACTED].
