**Probable Cause**

On October 10, 2025, at approximately 10:50 P.M., I (Trooper Lafleur ID#5261), responded to assist officer Ronquillo ID: 2389 with the West Palm Beach Police Department with a traffic stop on Clematis Street west of Sappodilla. Upon my arrival I spoke with Officer Ronquillo, and he advised he was responding to a disturbance call on Evernia Street and South Rosemary Ave. Upon arrival two individuals approached him and advised that the individuals causing the disturbance just left and she was traveling southbound on Evernia Street. A few seconds later he observed a blue Toyota

Highlander bearing a Florida license plate of Z82EEU traveling at a high rate of speed. He advised the vehicle failed to come to a complete stop at a red light and the driver of the vehicle failed to maintain a single lane of travel. He initiated a traffic stop by activating her emergency lights and sirens. The driver of the vehicle took a while to come to a complete stop. The driver of the vehicle eventually came to a complete stop on Clematis Street west of Sappodilla in an empty parking lot. When he approached the driver side of the vehicle, he observed a strong odor of an unknown alcoholic beverage coming from inside of the vehicle. While interacting with the driver outside of the vehicle in reference to the incident, he observed multiple signs of impairment such as; glassy eyes, slurred speech and a strong odor of an unknown alcoholic beverages emitting from her. I obtained a witness statement from officer Ronquillo. I later identified the driver of Vehicle by her Florida driver's license (M216703169000) as BIANA C MERLOS with a date of birth of 04/05/1987.

A short time later, I observed a blue Toyota Highlander bearing a Florida license plate of " Z82EEU". I approached the vehicle, and Ms. Merlos was standing outside of the vehicle. While standing outside of the vehicle I introduced myself and started interacting with Ms. Merlos. I asked Ms. Merlos if she was suffering from any major medical condition that I should be aware of, she stated no. I also asked her if she has any speech impediment problems. She stated no. I asked her if her vehicle has any major mechanical issues that I should be aware of. She stated no. While interacting with Ms. Merlos, I observed multiple signs of impairment such as slurred speech, bloodshot eyes and a strong odor of an unknown alcoholic beverage emitting from her breath that grew stronger each time she spoke. I asked her if she would like to get check by Fire Recue, she stated no. When I questioned her regarding her travel plans, she stated she was coming from a bar, and she was on the way home. I asked her if she had consumed any alcoholic beverages today. She stated yes. She advised she had one glass of wine about four hours ago. I also asked her if she was the owner of the vehicle. She stated yes. Ms. Merlos was the sole occupant of the vehicle. I asked her again if she has any major medical history that I should be aware of, she stated no. I asked her if she has any major speech problem or issues that I should be aware of. She stated no. While interacting with Ms. Merlos at times she was slow to respond and appeared lethargic; her speech was slow and slurred and other times she refused to stop talking. Ms. Merlos was very talkative and most of her sentences did not make sense at all. While standing outside of the vehicle and interacting with Ms. Merlos, I still smelled the strong odor of an unknown alcoholic beverage emitting from her breath that grew stronger each time she spoke. Ms. Merlos' mannerisms were distinct and consistent with someone who might be under the influence of alcohol or an unknown substance. I then asked Ms. Merlos if she was willing to perform Voluntary Standard Field Sobriety Exercises (SFSE'S). Ms. Merlos said yes, she agreed to do the exercises.

(Note: The summary below is not intended to be a verbatim account of all the events that took place during the administration of the standardized field sobriety exercises. Video footage and audio of the exercises is available upon request.) Each exercise was explained and demonstrated prior to the subject attempting to perform the exercise. The area where the exercises were conducted was clear of debris, on a flat surface.

**Horizontal Gaze Nystagmus (HGN):**

The first exercise that I performed with Ms. Merlos was the Horizontal Gaze Nystagmus exercise. I placed Ms. Merlos in a position with her feet together and her hands down by her sides. I asked Ms. Merlos a series of medical questions to ensure that she would be able to perform each of the exercises safely and without any deficiencies. Ms. Merlos advised me that she would not have any issues performing the exercises. I asked Ms. Merlos if she wears glasses or contact lenses. Ms. Merlos said no. I began the first series of passes with the stimulus, and I was checking each of her eyes for resting nystagmus and equal pupil size. I checked each of her eyes for equal tracking. I began the second series of passes, and I was checking each of her eyes for lack of smooth pursuit. I then checked each of her eyes for the onset of nystagmus prior to 45 degrees. Ms. Merlos eyes did exhibit the onset of nystagmus prior to 45 degrees. I checked each of her eyes for distinct and sustained nystagmus at maximum deviation. Both eyes exhibited distinct and sustained nystagmus at maximum deviation. During the Horizontal Gaze Nystagmus, Ms. Merlos was told to stay still multiple times and try not to move around as much. I checked each of her eyes for Vertical Gaze Nystagmus. I observed Vertical Gaze Nystagmus. Ms. Merlos exhibited an orbital sway throughout the duration of the exercise.

**Walk-and-Turn:**

The next exercise that I performed with Ms. Merlos was the walk-and-turn. I attempted to place Ms. Merlos in the starting position. She had a hard time maintaining the starting position. I explained and demonstrated the exercise for Ms. Merlos. I asked Ms. Merlos if she had any questions, she said no. Ms. Merlos began performing the first nine step series; she missed heel-to-toe on every step, counted 6 steps instead of nine and step off the line once. Ms. Merlos then began performing the second nine step series. During the second nine step series, Ms. Merlos missed heel-to-toe on every step, did not count her steps out loud and counted 6 steps instead of nine.

**One-Leg Stand:**

The last exercise that I performed with Ms. Merlos was the One-Leg stand. I placed Ms. Merlos in the starting position; I explained and demonstrated the exercise to Ms. Merlos. I asked Ms. Merlos if she understood the instructions and she advised me that she understood. I used a digital watch to count to 30 seconds. Ms. Merlos began performing the exercise, raising her right leg. Ms. Merlos put her foot down multiple times, did not count out loud, used both arms to help her maintain her balance and did not look at the raise foot as instructed to do so.

Based upon the above information and the totality of the circumstances I determined that there was probable cause to believe that BIANA C MERLOS committed the offense of driving under the influence by being in actual physical control/operating a motor vehicle while under the influence of alcoholic beverages, any chemical substance per Florida State Statute 877.111, or any controlled substance per Chapter 893, while their normal faculties were impaired. I placed BIANA C MERLOS under arrest for the above offense and handcuffed behind her back double locked spaced and tightened. She was placed under arrest at 11:25 M. After being searched, Ms. Merlos was placed in the back seat of my marked patrol (FHP3475) vehicle with the seat belt placed around him for her safety. Her vehicle was

towed By West Palm Beach Police. She was then transported to the Palm Beach County Breath Alcohol Testing (BAT) facility. I entered her info through FCIC/NCIC and her driver's license was not valid. I asked Ms. Merlos if she was aware that her license was not valid, she stated yes. At the BAT facility, I conducted a twenty-minute observation period while he did not ingest anything by mouth or regurgitate (mouth was confirmed to be empty prior to beginning of the observation period). Ms. Merlos was then asked if she was willing to provide a breath sample to determine the alcohol content of her breath. She said yes and then asked, "what if I said no". I then read Ms. Merlos the Florida Implied Consent driver's license suspension warning; I asked her if she understood, she stated yes. She refused to provide an answer on whether she would like to provide a sample. I asked her multiples time, and she still refuses. I advised her if I don't get a yes or a no from her then I would have to take it as a refusal. She still refuses an answer. After multiple attempts I advised her that I would call it a refusal. Ms. Merlos' refusal time was at 12:26 AM. See BAT video footage for a complete account of the incident.

Ms. Merlos was transported to the Palm Beach County jail for booking and processing and charged with DUI, Refusal to submit and DWLS.

She was booked without incident.

Ms. Merlos was issued a DUI citation. She was booked without incident.

All of the above events occurred in Palm Beach County, FL.

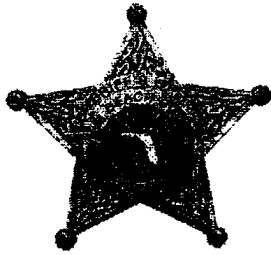
