PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Wednesday March 20, 2024 I responded to the intersection of S State Road 7 and Hypoluxo Road, located within Unincorporated, Palm Beach County Florida regarding a traffic stop with a suspected impaired driver. Upon arrival I met with D/S collura, #26708 who provided me with a signed, sworn written supplemental probable cause affidavit stating: " On 03/20/24 While driving my PBSO-marked patrol vehicle in the area of Highway 441 and Lantana Road (southbound), I observed a white four-door Toyota Camry (License plate 13AGUM) driving erratically. While monitoring the white Camry, I observed the vehicle violently drift into other lines beside it. While approaching red stop lights, the white Toyota Camry would come to an abrupt stop almost striking vehicles stopped at the red light. Continuing southbound through Lantana road, the Toyota Camry continuously crossed over the white stripped lines and was having extreme difficulty maintaining a single lane. I initiated a traffic stop while passing Hypoluxo Road and Highway 441. The white Toyota Camry continued to drive southbound but eventually pulled into the driveway located at 7515 South State Road 7. While approaching the white Toyota, I observed a white male (later identified as Brad Friedman) in the driver's seat. I asked the male again for his registration, he provided me with his wallet. I asked the male again for his paperwork, which then he finally provided to me".

OBSERVATION OF DRIVER:

I approached the defendant's vehicle on the driver side. He was the sole occupant. I introduced myself and asked the defendant to come speak to me by my patrol car. He stated "I don't know why you are doing this." as he exited. The defendant immediately used the car to brace and steady himself on. I observed the defendant to be unsteady on his feet. He kept stopping when I asked him to walk to my car. At one point he turned to face me, lost his balance and nearly fell into me. I observed the defendant to have a noticeable orbital sway as he stood. I observed the defendant's clothing was properly worn. I observed a wet stain on the center and right side of his shorts as we walked in front of me. The wind carried the smell from the defendant to me, leaving me with no doubt the defendant previously defecated in his pants. The defendant's eyes were red, glassy, and bloodshot. The defendant weaved and stumbled as he walked from their vehicle to the front of mine. The defendant's movements were clumsy, and uncoordinated.

DRIVER'S STATEMENTS:

The defendant initially said he had no alcohol. I asked again and [REDACTED] I asked again and he said [REDACTED]. The defendant told me he is not diabetic or epileptic. Additionally he told me he does not have any injuries and has no eye problems. I asked the defendant to submit to voluntary field sobriety tasks. He said he was not sure if he wanted to, so I explained his Taylor Warnings, which he said he understood. He refused again to submit to tasks.

ODORS:

I immediately detected the odor of an unknown alcoholic beverage emanating from the defendant's breath that intensified when the defendant spoke.

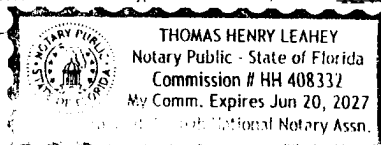

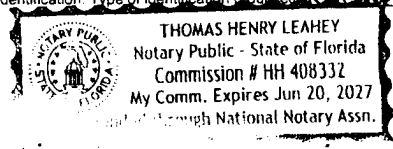

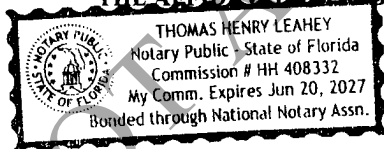
