<p>On Sunday November 05, 2023 at approximately 0138 hours, while responding to a call of a possible impaired driver, I observed a Blue BMW 4 door traveling eastbound on Southern Blvd (State Road 80). The vehicle was in the far right lane when I first observed it. The vehicle swerved into the lane to its left partially before returning to the outside lane. The vehicle continued to swerve heavily between two lanes of traffic. Additionally, I attempted to get close enough to the car to obtain a speed reading on my in car APPLIED CONCEPTS STALKER DSR 2X RADAR S/N: DP018959. The vehicle maintained a significant distance in front of me. I reached a speed of 80 miles per hour in a posted 55 zone attempted to obtain a target reading. The car continued to pull away from me. I confirmed the speed on the calibrated speedometer and confirmed a patrol speed of 80 miles per hour. Again the target vehicle was pulling away from me. Inv. K. Noel #7660 was behind me also traveling to a seperate call. I called him on the phone briefly and told him I would continue to the call, and he could break to address the BMW. As we continued to travel east on Southern Blvd approaching the off ramp for Jog Road, the car appeared as if it was aiming towards the off ramp, or exit for Jog Road. It then swerved hard left and continued east bound on Southern Blvd. At that time the vehicle began to slow. Inv. Noel was behind the car at that point, and I overtook it. Approximately 20 minutes later, I arrived on scene of Inv. Noel's traffic stop. Shortly after my arrival, the defendant stated he wanted to get his phone from his vehicle and began to walk towards the open car door. Due to the contents of the vehicle being unknown, and the potential for him to try to drive away, I moved my body between him and the vehicle, and placed my hand out in front of me. The defendant walked towards me until his chest made contact with my hand. He then turned away and made no further attempt to enter the car. He demanded he be able to record this encounter with his cellular phone. He was informed there were currently four body worn camera's as well as in car cameras capturing the encounter, and that he was not to return to his vehicle. D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On November 5th, 2023 at approximately 0140, I was traveling eastbound on State Road 80 from the area of Jog Road when I observed a small dark vehicle traveling ahead of me along the outside lanes of travel crossing over both lines and nearly hitting the guardrail. It should be noted that I had been traveling behind Inv. W. Amadeo ID 9448 as we were both responding to a call together. Inv. Amadeo continued on to the other call as I broke off and caught up to the above mentioned vehicle. Inv. Amadeo's observations just ahead of me were also provided on a sworn PC affidavit to the following:

On Sunday, November 5th, 2023 at approximately 0130 hours, while responding to a call of a possible impaired driver, I observed a Bmw BMW 4 door traveling eastbound on Southern Blvd (State Road 80). The vehicle was in the far right lane when I first observed it. The vehicle swerved into the lane to its left partially before returning to the outside lane. The vehicle continued to swerve heavily between two lanes of traffic. Additionally, I attempted to get close enough to the car to obtain a speed reading on my in car APPLIED CONCEPTS STALKER DSR 1X RADAR S/N: DP918959. The vehicle maintained a significant distance in front of me. I reached a speed of 80 miles per hour in a posted 55 zone attempted to obtain a target reading. The car continued to pull away from me. I confirmed the speed on the calibrated speedometer and confirmed a patrol speed of 80 miles per hour. Again the target vehicle was pulling away from me. Inv. K. Noel #7660 was behind me also traveling to a separate call. I called him on the phone briefly and told him I would continue to the call, and he could break to address the BMW. As we continued to travel east on Southern Blvd approaching the off ramp for Jog Road, the car appeared as if it was aiming towards the off ramp, or exit for Jog Road. It then swerved hard left and continued east bound on Southern Blvd. At that time the vehicle began to slow. Inv. Noel was behind the car at that point, and I overtook it. Approximately 20 minutes later, I arrived on scene of Inv. Noel's traffic stop. Shortly after my arrival, the defendant stated he wanted to get his phone from his vehicle and began to walk towards the open car door. Due to the contents of the vehicle being unknown, and the potential for him to try to drive away, I moved my body between him and the vehicle, and placed my hand out in front of me. The defendant walked towards me until his chest made contact with my hand. He then turned away and made no further attempt to enter the car. He demanded he be able to record this encounter with his cellular phone. He was informed there were currently four body worn camera's as well as in car cameras capturing the encounter, and that he was not to return to his vehicle. He was argumentative, and continued to demand a lawyer be called to the roadside.

I, Inv. Noel continued to follow the vehicle eastbound on State Road 80 as it began to exit onto Haverhill Road to turn southbound. I observed the vehicle roll to a near stop at the solid red light, but did not come to a complete stop. The vehicle then began to travel southbound on Haverhill Road passing through Gun Club Road and approaching Summit Blvd when I observed a FL tag of "MMMMMM" attached to a dark Bmw BMW. I subsequently initiated a traffic stop on this vehicle, which continued to travel slowly; failing to pull over at plenty of safe locations until finally turning onto Summit Pines Blvd and coming to a stop.

OBSERVATION OF DRIVER:

I approached the driver still seated in the driver's seat of the above mentioned BMW who was the sole occupant of the vehicle. I observed the driver to be wearing a beige tee shirt with dark shorts and gray sneakers. It should be noted that I had received a FL D/L to identify the driver as the above listed and was determined to be the current registered owner of the vehicle. I immediately observed an obvious odor of an unknown alcoholic beverage coming from the interior of the vehicle along with vomit, where I observed vomit all over the driver's chest area. I observed the driver to be very dazed and disoriented as he looked at me; like he was looking through me with a red flushed face. I also observed the driver's eyes to be glassy and red bloodshot; driver was wearing glasses, as well. I removed the driver from the vehicle and escorted him to the front of my vehicle. The driver was unsteady on his feet as he walked over towards my vehicle. As the driver spoke through a slurred speech, this obvious odor of alcohol did greatly intensify. I did check the drivers eyes for equal tracking and equal pupil size.

DRIVER'S STATEMENTS:

The driver stated that he had been coming from West Palm Beach and had two bottles of Bud Light within the hour. It should be noted that the driver was traveling east in the direction of West Palm Beach. The driver then stated that he was coming from a friends house. The driver was repeatedly argumentative with me as I explained the circumstances revolving around this investigation; continued to talk over me wanting his attorney present. The driver refused to answer questions for the rough arrest portion of the paperwork; further willfully refusing to also sign the NTA for DUI stating that he wanted his lawyer present. Therefore in addition, the driver was charged with failure to accept a summons. See video for further.

ODORS:

I immediately detected the odor of an unknown alcoholic beverage emanating from the defendant's breath that intensified when the defendant spoke.

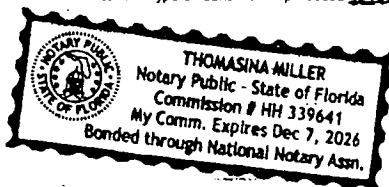

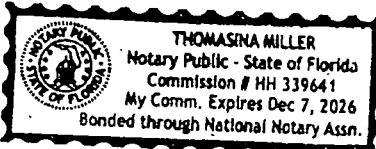

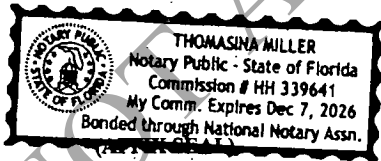
