

Owen's supplemental report).</p> <p>Upon my arrival, PFC. Owen informed me that Bradley Berg had a strong odor of an unknown alcoholic beverage emanating from his breath. I made contact with B. Berg and asked if he would step away approximately 10 yards south from where he was sitting to speak with me to which he consented. I spoke with Berg and asked what had occurred and he stated that he was trying to take his son to the hospital but made a wrong turn and turned onto the railroad tracks. B. Berg said he has made this turn multiple times before but made a mistake today. While speaking with him, I detected a strong odor of an unknown alcoholic beverage emanating from B. Berg's breath and observed him to have bloodshot, red glossy eyes. I asked B. Berg if he had anything to drink prior to our interaction to which he stated he had one Ale couple hours ago. Based on my observations and PFC. Owens observation, I asked B. Berg if he was willing to submit to standardized field sobriety tasks (SFSTs) to determine if he is okay to drive. B. Berg was willing to submit. I asked B. Berg if he had any disabilities or defects that would prevent him from completing the tasks I would request of him to which he stated no except old age, high blood pressure, and seizures. I conducted HGN. While Berg was in the starting position, he would sway back and forth. Berg had to be reminded throughout the task multiple times to keep his head still. While completing the task, Berg continued to sway back and forth. Berg showed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation and onset of nystagmus prior to 45 degrees in both eyes.

Walk and Turn:

I conducted walk and turn. During the instruction stage, Berg stepped off the starting position and started without being told to. I had to place Berg back into the starting position approximately two times. Berg said he understood the instructions and did not have any questions. As Berg completed the task, he missed heel-to-toe on steps 1, 2, and 5. Berg completed 10 steps opposed to the nine I had explained to him. Once completing the first set of nine heel-to-toe steps, Berg stopped. I asked him if he remembered the instructions I had explained and reminded him to take a series of small steps and complete nine heel-to-toe steps back. On the nine heel-to-toe steps back, Berg missed every heel-to-toe step and completed 10 steps. Berg also stepped off the line on step nine and ten.

One Leg Stand:


I conducted One Leg Stand. Berg at first did not explain the instructions I had explained and was becoming irate stating he couldn't do it on a normal day. I asked Berg if he wished for me to explain the instructions to which he stated yes. After reexplaining the instructions, Berg did not have any questions. Berg lifted his left foot approximately 6" off the ground and used his right arm for balance. Berg proceeded to lower his foot approximately six times total. After lowering it the sixth time, Berg did not continue with the task.

Finger to Nose:

I conducted Finger to Nose. Berg stated he understood the instructions and did not have any questions. I asked Berg if he knew the difference between his left and right and he stated yes. I put Berg in the starting position and explained to him the clear difference between the tip/pad/nail of his finger and he did not have any questions. On the first "left", Berg missed the tip of his nose and touched his left eye. On the third "right", Berg lifted his left hand then quickly lowered it and used his right hand to touch the tip of his nose.

Romberg Alphabet:

I conducted Romberg Alphabet. Berg stated he understood the instructions and did not

have any questions. He closed his eyes and began to recite the alphabet in the following manner:

"A,B,C,D,E,F,G,J,K,L,M,N,O,Q,R,S,T,U,V,W,X,Y,Z"

Based on the above investigation findings, probable cause exists to charge Berg for driving under the influence. I placed him into handcuffs which were double locked and checked for proper spacing at approximately 0100 hours. Kauff's towing arrived and towed his vehicle from the scene to their lot. I asked Berg if he was willing to provide a breath to which he was undecisive. I transported him to the Palm Beach County Breath and Alcohol Testing Center. Upon arrival, Berg was placed under observation for 20 minutes which began at 0130 hours where he did not consume or regurgitate anything. After observation period, Berg provided two breath samples of .183 at approximately 0212 hours and .177 at approximately 0215 hours. I read Berg his Miranda Warningst to which he acknowledged.

Berg was issued a citation for DUI - BAC above .15 (AJL70JE). Berg was booked into the Palm Beach County Jail pursuant to FSS 316.193(4) DUI - BAC above .15/ Berg was given a court date of 02/26/2025 at 0830 hours at the North County Courthouse in Palm Beach Gardens. The above statements and events were captured on my agency issued BWC and should not be purported to be verbatim.
