The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was stopped after he ran a stop sign, then stopped blocking the crosswalk when he stopped at a steady red traffic signal. The defendant was driving his 2021 Cadillac SUV, bearing FL tag #ERIJ86. Upon making contact with the defendant, he displayed multiple signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on his breath, slurred speech, extremely sluggish reflexes and delayed responses to simple routine questions, difficulty dividing his attention, and staggering when he walked. The defendant refused to perform any SFSEs and was arrested for DUI. The defendant later refused to submit to the breath test, despite being advised of the Implied Consent Warning. The defendant has a prior refusal to submit to DUI testing on 05/25/2014.

A search of the defendant incident to his arrest revealed the attached bar receipt, which detailed the purchase of 6 alcoholic beverages just hours before being stopped, despite his claim to not having consumed any alcoholic beverages at all.

The defendant identified himself via his FL driver's license.
