NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the 02 of March 2024 at 0:00 at WEST IRLO BRONSON MEMORIAL HIGHWAY/ BALI BLV, WINTER GARE (Zone: 309) in Orange County did

On 03/02/24 at approximately 0128 hours, I backed up Deputy Justin Breaud who had conducted a traffic stop. Upon my arrival, I observed Deputy Breaud making contact with the driver of a gray Nissan sedan bearing FL BL30ZE. Shortly later, Deputy Breaud requested the driver to exit the vehicle and he advised the driver appeared impaired. See Deputy Breaud's supplemental report for further details. Deputy Breaud advised the reason for the traffic stop to me, which time I began speaking to the female driver who was identified as Brigitta Nedoba by her Florida driver's license. While speaking to Brigitta I could smell the odor of alcohol impurities coming from her person. Brigitta stated she was coming home from the club located in downtown Orlando. She stated she had consumed three vodka and cranberry drinks at the club. I observed her eyes to be glassy and I continued to smell the impurities of alcohol as she spoke. Based on the observations, I requested Brigitta preform field sobriety exercises, which she stated she would. PRE medical screening Brigitta stated she is a diabetic and she takes medications, which she last took the morning of March 1st. Brigitta stated she has no injuries and has had no head trauma. HGN For this exercise, I provided the instructions to Brigitta and she stated she understood. I observed her eyes to be brown in color, no resting nystagmus and she had equal tracking. I observed the following clues; Lack of smooth pursuit in both eyes Distinct and sustained nystagmus at maximum deviation in both eyes Walk and Turn For this exercise I provided the instructions and demonstrated the exercise. I observed the following clues; Lost balance in starting position Began walking before told to do so Incorrect number of steps Incorrect turn Stepped off line Missed Heel to toe One Leg Stand For this exercise, I provided the instructions and demonstrated the exercise to Brigitta. I observed the following clues; Sway Puts for down. Based on the investigation, it was determined that that Brigitta was in violation of F.S.S 316.193 and she was placed under arrest. Ace wrecker towed Brigitta's vehicle and she was transported to the Orange County Sheriff's Office DUI testing center. Once at the testing center, Brigitta was observed for 20 minutes then given the opportunity to provide a breath sample, which were 0.122 at 0324 hours and 0.131 at 0327 hours. Brigitta was issued a DUI citation for the unlawful breath (AFX0PKE). Brigitta was transported to BRC without incident.
