

<p>On Sunday, November 16th, 2025, at approximately 2153 hours, I was conducting a uniformed patrol in my marked patrol vehicle when I was dispatched to a careless driver in the area of Marcinski Rd and S US Highway 1.</p> <p>Northcom dispatched advised they had received a 911 call about a vehicle traveling north bound on S US Highway 1 in the south bound lanes. I positioned my marked patrol vehicle in the median of S US Highway 1, at the intersection with Olympus Cir, and waited for the vehicle to pass. I then observed headlights approaching north in the south bound lanes at a high rate of speed. I initiated my emergency lights and sirens, in order to get the vehicle to stop. The vehicle drove right passed my patrol vehicle, and I was able to identify it as a white Mercedes SUV. I then made a U-Turn, with my emergency lights and sirens activated, began traveling north in the south bound lane of S US Highway 1 in an attempt to catch up to the white Mercedes.</p> <p>The white Mercedes came to a stop just south of the intersection of S US Highway 1 and Ocean Way. Upon walking up the driver, the driver rolled down her driver side window. When the window was rolled down, I noticed the odor of an unknown alcoholic beverage emanating from the driver I asked the driver for her license, registration, and proof of insurance. The driver moved lethargically inside of the vehicle, and was able to produce her Florida Driver License, identifying the driver as Brit M Bankemper (W/F 10/02/1980). When the driver spoke, she took long pauses before answering questions, and then spoke in a slow, slurred manor. I then reminded Bankemper to provide her registration. Bankemper, continuing to move in a slow, lethargic manner, was able to produce her registration. I then reminded Bankemper to provide her proof of insurance. Bankemper then showed me the title of her vehicle, and I told her that I needed to see her insurance. Bankemper then stated, "please don't take me". When I asked her what she meant, she asked if she could move her vehicle to the correct side of the road, to which I told her no. I then reminded Bankemper again, to provide her proof of insurance. 
was able to provide the proof of insurance after some time looking through her phone. I then asked Bankemper where she was coming from. Bankemper stated she came from AquaSan, a restaurant in Juno Beach. I asked Bankemper if she had had anything to drink tonight, and Bankemper responded that she had two or three drinks. At this time, I asked Bankemper to step out of the vehicle.

When Bankemper stepped out of the vehicle, to which she complied, and moved to the rear of her vehicle as I directed. Now that she was standing closer to me, I asked Bankemper to reiterate what she was doing tonight, prior to the traffic stop. Bankemper stated she was eating dinner with a friend at AquaSan as mentioned above. She then stated that the roads were confusing in the Abaccoa area. I stated to Bankemper that we currently were not in Abaccoa. She stated she was in Abaccoa earlier in the night at a bar named Nieko's. Bankemper then stated "if you are going to take me, then just take me in". I asked Bankemper if she was willing to perform tasks to make sure she was ok to be driving, and Bankemper refused to answer. Taking her refusal to answer as a no, I read Bankemper the Taylor Warnings, and asked if she understood. Bankemper then refused to answer. I asked her once again if she was willing to preform the tasks, and Bankemper refused to answer. Based on the above, probable cause was established to arrest Bankemper for DUI pursuant to FSS 316.193. Bankemper was placed into handcuffs, double locked and checked for proper spacing, and taken to the passenger side of my patrol vehicle to wait for a female officer to conduct a search of her person.

As I waited for the female officer, I asked Bankemper if she was willing to provide a sample of her breath to determine the alcohol content. Bankemper refused to answer. I read Bankemper implied consent, to which Bankemper again refused to answer. I asked Bankemper to the answer the question, and failure to answer the question would result with the answer being taken as no. Bankemper refused to answer. Based on the above, Bankemper was charged with refusing a lawful breath test under FSS 316.1939(1).

Bankemper was then transported the Jupiter Police Department for processing, and later transported to the Palm Beach County Jail without incident.

The above is a summary of events, captured on my department issued Axon Body Worn Camera.





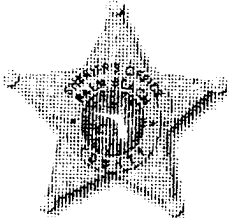
