Before me this date personally appeared OFC S GIANINO who being first duly sworn
deposes and says that on 22 day JANUARY, 2024 at 4500 N FED HWY (crime location)
the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows

Narrative

On January 22, 2024, I responded to 4500 N Fed Hwy Unit 339E in reference to a domestic disturbance. Upon arrival, I made contact with the above defendant who advised her ex-boyfriend, [REDACTED], arrived at the above location unannounced to retrieve clothing for his 15 year old son, Aiden [REDACTED]. It should be noted that [REDACTED] and the defendant have been residing in this apartment as a family for the last 9 months and the couple has shared a domestic partnership for the last 1.5 years that ended this past Saturday. While the son was inside retrieving clothing due to the recent separation, [REDACTED] began knocking on the door. When Brittany partially opened the door to let Aiden leave the apartment, [REDACTED] entered the apartment to retrieve his clothing. While walking inside the residence towards their bedroom, [REDACTED] stated that the above defendant pulled his shirt causing him to fall backwards, hitting a small table in the entry way with his ankle. I interviewed Aiden separately and he also stated that when his father attempted to enter the home, the above defendant blocked him and began grabbing him and pulling at his shirt, screaming for him to leave.

The above defendant stated that she did not want [REDACTED] to enter their shared residence as they are going through a separation. She stated that when she opened the door to allow Aiden to leave, [REDACTED] entered abruptly and she pulled on his shirt to get him out.

[REDACTED] sustained visible injuries to his right ankle consistent with his statements. Due to the stretchy material of the shirt, there was no obvious tearing. The victim refused to cooperate with the investigation and did not provide a taped sworn statement.

Upon conclusion of this investigation, I find probable cause that the above defendant committed battery, domestic violence, as she actually and intentionally touched [REDACTED] against his will when she pulled his shirt causing him to fall back and injure his ankle.
