On Wednesday, January 25, 2023, at 00:36hrs, I, DUI Investigator Cameron Carver, was at PGA Boulevard and Shady Lakes Drive, in the City of Palm Beach Gardens, within Palm Beach County, Florida conducting traffic enforcement in a construction zone. My department issued body worn camera and in-car dash camera was utilized in this investigation and subsequently uploaded to Evidence.com.

I observed a black Chevrolet Suburban bearing Florida license plate GWAZ12. The Suburban was traveling eastbound at an estimated speed of 75mph in a 45mph zone, as well did not have his head/taillights on. My mounted Stalker DSR2X radar system (SN: DB018975 Antenna SN: KR044789) displayed a speed of 73mph with doppler tone. I caught up to the Suburban, which was now traveling southbound on N Military Trail, still with no lights on and activated my emergency equipment to order the vehicle to pull over. The Suburban pulled over upon the command on the right shoulder.

I made contact with the driver and sole occupant of the vehicle, identified by his Kansas Driver's License as Bryan Edward Meyer. Meyer was dressed nicely, and was polite upon contact, however I was met with the strong odor of unknown alcohol at the driver's window. I explained to Meyer the reason for the stop and requested his license and rental agreement, due to the vehicle being a rental vehicle. During my interaction with Meyer, I was able to determine that the "auto" feature for the lights was not functioning properly, however two clicks to the right was the manual option for the headlights, which worked properly. Meyer had difficulty looking for his cell phone, which was right next to him on the middle armrest. Meyer had bloodshot and glassy eyes and his speech was slurred. He stated to me he was coming from Abacoa in Jupiter, Florida. Meyer initially stated he had no alcohol, then very little alcohol, then stated he had four wines, then he stated he had bought alcohol for his clients this evening, but did not recall how much alcohol he actually consumed.

I requested Meyer to exit the vehicle as he struggled to log into the phone app for his rental, to show that he had a valid rental agreement. As he was walking to my vehicle, he was unsteady and swayed. He had to lean on my vehicle for support. While standing outside of my vehicle and with my backup officer, Officer Borgela #534, he confirmed the validity of the rental agreement. I issued Meyer a citation for his speed and articulated to him my concerns of impairment, notably his speed, driving with no lights, his unbalance, his slurred speech and the strong odor of alcohol coming off of his breath while he spoke, while outside.

I requested Meyer to perform a series of Standardized Field Sobriety Exercises, which he promptly refused. I explained to him his Taylor Warnings, to which he stated he understood and again refused. At which point, I informed Meyer he was now under arrest and requested he remove his jewelry and belt. Meyer was searched incident to arrest, finding nothing on his person. Meyer was placed into three sets of handcuffs for comfort, which were checked for proper fit and locked. Meyer was subsequently placed in the back of my patrol vehicle without issue. Due to the vehicle being a rental and going back to the rental company, I removed Meyer's personal property (wallet, credit cards and sports jacket). Inside the sports jacket was multiple receipts, which were photocopied and supplied with this report.

Meyer was transported to the Palm Beach County Breath Alcohol Testing Center (BAT) without incident. Upon arrival at the BAT, Meyer was placed in seat and was observed for 20 minutes and did not ingest anything or vomit. While at the BAT, Meyer was respectful, quiet, and professional. At the end of the observation, I brought Meyer on camera, with Palm Beach County Sheriff's Office Breathalyzer Technician Thomas Leahey ID#19183 present and requested Meyer to submit to the breath test where he stated he did not understand. I read Meyer the Implied Consent to which Meyer stated again he did not understand. I explained to Meyer in "layman's terms" the implied consent twice, which he again stated he did not understand, and also stated he did not want to be difficult. I explained to Meyer his repeated lack of understanding is not a defense to the refusal and to explain what he did not understand. Meyer was unable to state what aspect he did not understand. Meyer then requested an attorney, which I explained he did not have the right to one in the testing room or access to consult prior to giving a breath sample, which he appeared shocked about. Meyer again stated he did not understand after having him explain to me the consequence of refusing and asking for an attorney, therefore I called the refusal at 01:54hrs. Meyer was read Miranda Warnings from a pre-printed document, which he understood. Meyer was taken to intake without incident.

Based on the totality of circumstances from my investigation, I find Bryan Edward Meyer drove a vehicle on the streets of Palm Beach Gardens, while under the influence, and was affected to the extent that his normal faculties were impaired, in violation of Florida State Statute 316.193(1)(A) [AGEUP4E], as well as Unlawful Speed on a State Road, in violation of Florida State Statute 316.187(1) [AGEUP3E]. Meyer was provided copies of

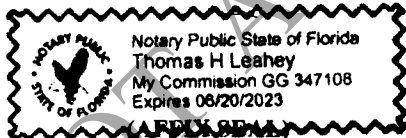
