On March 30, 2025, I responded to 2015 Graden Drive Palm Beach Gardens, Florida 33410, in reference to a domestic disturbance. Upon arrival, I made contact with Carisa Deitz who reported the following.

Carisa stated that she and her husband Andrew had been arguing and Andrew went into the garage and was working on a motorcycle. She was upset that he was not spending time with the family inside. She went outside and grabbed the headphones he was wearing on his head and removed them. An argument ensued and she stated that Andrew pushed her up against the wall and was choking her with both hands. I visually inspected Carisa's neck and did not observe any injuries or redness to her neck. I asked Carisa how Andrews face and arm got scratched and she advised it was during the scuffle but she wasn't sure exactly.

Officer Lexi Bruorton # 582 originally made contact with the victim, Andrew Deitz who reported the following. Andrew advised that he and his wife Carisa had been arguing so he went outside to work on the motorcycle in the garage. Andrew stated that Carisa came outside and grabbed the headphones off his head and threw them against the car. Andrew stated that Carisa began attacking him by scratching his face and arms. He stated he grabbed Carisa by one arm and used his other hand to push her back at her neck to get her away from him. He then told Carisa he was calling the police. A visual inspection of Andrew's face revealed a scratch to his right cheek and also scratches to his right arm.

Based on the above information, Probable Cause exists to charge Carisa Deitz for violation of F.S.S. 784.03 (1) (A) (1) for Simple Battery (Domestic) against Andrew Deitz.
