The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/21/2023 at approximately 0401 hours, Deputy J. Calmbacher (ABN# 257109), observed a white Jeep Cherokee, bearing FL tag 34CDZB, failing to maintain its lane and braking erratically, on 19th Ave NE, Sun City Center, FL 33573. Deputy Calmbacher conducted a welfare check stop of the vehicle in the area of 19th Ave NE, and Copperfield Bell Pl, Sun City Center, FL 33573. Deputy Calmbacher contacted the defendant who was in the driver's seat and sole occupant. Deputy Calmbacher observed indicators of impairment from the defendant, and requested the affiant respond to the scene. The affiant made contact with the defendant and observed her to have bloodshot, watery, glossy eyes, slurred speech, was unsteady on her feet, and was emitting the odor of an alcoholic beverage from her breath. The defendant admitted to drinking alcoholic beverages prior to contact. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was subsequently placed under arrest for DUI. The defendant was read the Florida Implied Consent Warning, advised she understood the warning, and provided two lawful breath samples (.227/.230) BrAC. The defendant was identified via her valid Florida Driver's License.
