**NARRATIVE:** The undersigned has probable cause to believe the above-named defendant on the 10 of November 2023 at 22:53 at 6100 WAVE HOTEL DRIVE (Zone: k7) in Orange County did

On November 10, 2023, at approximately 2237 hours, I, Officer W. Jackson (35637) responded to 6100 Wave Hotel Drive (Lake Nona Wave Hotel) in reference to a trespasser. Upon arrival, I made contact with Carmen Cintron Vazquez (Suspect) who was refusing to leave the property.

Cintron Vazquez was asked multiple times to leave the property by the hotel staff to which Cintron Vazquez refused and continued to remain on the property. Officer C. Ehlers (18703) and I also asked Cintron Vazquez to leave the property to which she refused and continued to remain on the property.

It should be noted Cintron Vazquez was intoxicated and I could smell alcohol on her breath.

Officer Ehler made contact with the manager, Samantha Nsiah, who provided the following sworn written statement:

Cintron Vazquez entered the restaurant in the hotel and was already intoxicated upon arrival. Cintron Vazquez then had one drink and that is when the staff cut her off. Cintron Vazquez then became disruptive. Nsiah then called for security to have Cintron Vazquez escorted off the property. Cintron Vazquez refused and continued to remain on the property. Nsiah then called the police to have Cintron Vazquez removed from the property. Nsiah stated she will press charges on behalf of Lake Nona Wave Hotel.

Based on the investigation probable cause exist to charge Cintron Vazquez with Trespass on Property After Warning F.S.S 810.09-5 due to Cintron Vazquez refusing to leave the property of the Lake Nona Wave Hotel after being asked to leave multiple time.

Cintron Vazquez was arrested and transported to BRC without incident.
