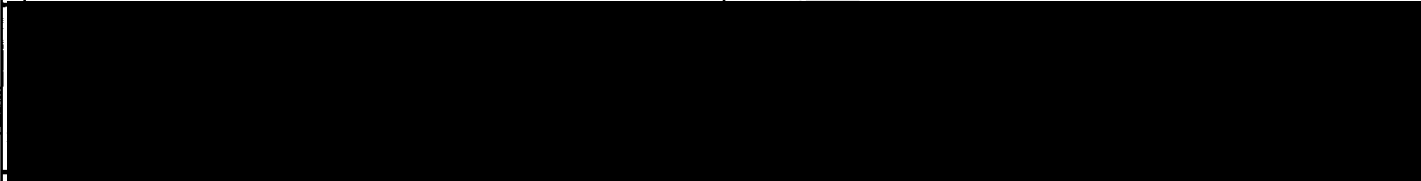

On the **21** day of **April**, **2023** at **23:49** (Specifically include facts constituting cause for arrest.)



On April 21, 2023 at 11:49 p.m. I was dispatched to the Firefin Grille at 2401 PGA Boulevard in Palm Beach Gardens, Florida in reference to a battery that had just occurred. Dispatch gave the description of the suspect as a white female wearing a multi-color dress. Upon my arrival, I located a female matching the description walking on the west side of the business. My body worn camera was used during this investigation.

I made contact with the female who was identified as Casandra Bozydaj who was attempting to leave in an Uber. I told her she was not free to leave as I was investigating a battery that had occurred. I asked her what happened to which she said her and the staff got in an argument over the bill. They said she did not pay it and she believed that she did. Throughout the questioning, Bozydaj was visibly intoxicated, uncooperative and began verbally degrading the staff.

I then made contact with Farah Rousseau who stated that she witnessed the incident and provided me with a sworn statement. Rousseau stated that Bozydaj asked to use her phone to call her boyfriend because hers was dead. She said the she then heard Bozydaj began arguing with one of the staff members which turned into Bozydaj attacking the female employee by pulling her hair. Rousseau was not affiliated with the business and was only a patron at the time of the incident.

I then made contact with the victim, [REDACTED] who provided me with a sworn statement. [REDACTED] stated that she was alerted by another staff member that there was a dispute over the bill being paid. [REDACTED] made arrangements to get the bill paid for and then requested Bozydaj leave due to her verbally abusive behavior. Bozydaj was told to leave several times by [REDACTED] who said that Bozydaj attacked her by grabbing her hair and pushing her. [REDACTED] declined EMS and had no visible injuries.

<p>I spoke with another employee, Arlen Rubio who said she saw the incident and provided me with a sworn statement. Rubio stated she heard the two argument and when she looked over, she observed Bozydaj push [REDACTED] at which point Rubio separated the two.</p> <p>As a result of my investigation to include the statements from all parties, I find probable cause to charge Casandra Bozydaj with simple battery pursuant to F.S.S. 784.03(1)(A)(1). Through out the arrest and processing, Bozydaj was verbally aggressive. It should be noted that at 10:13 p.m. on the same date, there was another battery to an employee at another nearby establishment. Due to lack of prosecution, no charges were filed (23-002195).</p>

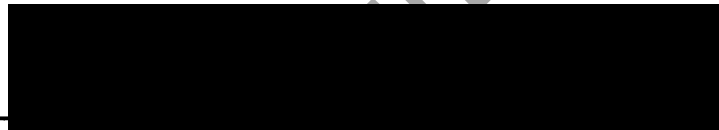
