On 06/02/2024 at 2309 hours, I responded to [REDACTED] in reference to BRPD case number 24-6625.

Prior to my arrival, the caller Carla Auran, advised she had just been attacked by her ex-boyfriend Chad Breneman inside of her apartment. Upon arrival in the apartment (407), I met with Carla who appeared to be visibly upset. She advised that she had just returned from dinner with Chad and asked that he drop her off at the front. She advised that Chad then followed her into the building and then up to her apartment. Carla remained adamant that she did not invite Chad into her building or into her apartment and that he walked inside after she did.

Carla stated once inside the apartment, Chad began walking around, took off his shirt, and then went into her bedroom. He then walked back into the main area of the apartment to the kitchen.

Carla advised that she again asked Chad to leave, and he advised that he wanted to stay to take her to her doctor's appointment. Carla advised she then grabbed Chad to assist him in leaving her apartment at which point, she advised he became angry. She advised that he aggressively pushed his right forearm into her chest and then pushed her into the glass dining room table behind her. While speaking with Carla it should be noted she advised she did try to get Chad off her by flailing as he had his forearm across her chest and her pinned down on the table. Prior to our arrival, Chad left in his white Lexus bearing a FL tag of Y27BTK.

[REDACTED] could like to note that per Carla since she moved to the above address [REDACTED], Chad has been invited over to her apartment on countless occasions and as often as once a week prior to their break-up one week ago.

I visually observed what appeared to be fresh redness and red marks on Carla's chest

just below her neck. Additionally, I observed fresh red scratch marks on her back. The dining room appeared to be disturbed and the dining room table was noticeably pushed back consistent with Carla's statement. Using my BRPD issued MVR camera, I took photos of Carla's injuries and the inside of the apartment where the incident occurred.

Carla provided a sworn statement to Ofc. Izquierdo which was captured on his BRPD issued MVR. It should be noted that while providing her sworn statement Carla stated that she did initially invite Chad into the apartment so that he could see the dogs. Carla and Chad were in a three-year relationship which ended approximately one week ago.

On 06/03/2024 at 1900 hours I met with Chad Breneman in the parking lot of the Boca Raton Police Department. He was advised that I was conducting a criminal investigation into what had previously transpired. He was read his Constitutional Warnings from a preprinted department issued Constitutional Warnings card.

He advised that last night (06/02/2024) he and Carla Auran arrived at her residence (899 Jeffrey St.) after having dinner. He stated that he was invited up to the apartment as he was under the impression, he would be taking care of Carla following a surgery she was set to have on today's date (06/03/2024).

Once inside of the apartment, he advised Carla became irate asking him to leave which he stated he would only after he got items from the fridge belonging to him. He advised while in the kitchen, Carla attempted to stop him so that he would leave. He advised that she then picked up a chair which was located on the side of the table closest to the kitchen and struck him with it.

After being struck, he advised that he grabbed her on either side of her arms. It should be noted that I reviewed the photographs taken at the scene the night of the incident. There were no chairs placed consistent to his account of what occurred. Additionally, Chad stated that he was unsure of how Carla would have injuries to her back or chest consistent with her account of the incident. Chad had a scratch on right arm which he claims he received after being hit with a chair.

Based on the injuries to Carla, and the state the apartment was in following the incident I developed probable cause to charge Chad Breneman in violation of F.S.S. 784.03(1A1), after he intentionally pushed the victim causing minor injuries to her back and chest area.


