the residence and he also called 911.

Officer Raleigh, PFC Tappin, and I arrived on scene near the same time. Officer Raleigh spoke with Dilbert, while PFC Tappin and I spoke with Haberman. Haberman provided the following statement:

Haberman stated he and his mother got into an argument about the Ring doorbell camera that he wanted access to. He explained that he and his mother were undergoing a civil dispute in reference to money and his current living situation. He stated that the argument with Dilbert never got physical. He further stated, that she was trying to evict him, but he was going to appeal the civil litigation the following week. (end of Haberman's statement).

During my interview with Haberman, his emotions were high and statements were scattered as he kept referring back to past events as if it occurred that night.

Officer Raleigh informed me that after speaking with Dilbert, she reported being assaulted by Haberman and she had a minor injury to her left knee. Due to Haberman's size and high emotions, PFC Tappin and I placed Haber in protective custody, double locking the cuffs, and checking for proper spacing. Haber was placed in my patrol unit while I spoke with Dilbert in side the residence, she provided the following sworn statement:

Dilbert stated that Haberman was served eviction papers on 11/8/2025 and this made him very angry. She said he demanded to have access to her Ring doorbell camera that was located on her residence. She said he became enraged when she initially denied his demands. She said she went into her bedroom to stay away from him, but Haberman pursued behind her, forcing his way through her closed bedroom door. When Haberman forced his way through the bedroom door, she said he grabbed her left arm and punched her in the left leg with a closed fist, causing minor swelling to her left knee area. Then Haberman snatched her cell phone off her bed and at that moment, she decided to let him see the Ring footage because she feared he would hurt her. She attempted to tell him that she would allow him look at the camera, but he threw her phone across the bedroom knocking all of her identification/insurance cards all over the bedroom floor. Dilbert said she was able to pick up her phone, walk outside, and called 911.

I completed a Domestic Violence Lethality Assessment with Dilbert, and based off the score of the assessment, I determined that Dilbert is in a potentially lethal situation. I provided her with a Domestic Violence Victim's Rights Brochure and explained it to her. Due to the location of her injury, Officer Raleigh took photos of Dilbert, which were later uploaded to evidence.com.

Based on the above facts, statements, and the totality of circumstances, I determined that Haberman was the primary aggressor in the incident and probable cause was established to charge Haber with FSS 784.03 (1) (A) (1) - Domestic Battery (Strike or touch).

Haberman was transported to the Jupiter Police Department for processing and preparation for the Palm Beach County Jail. Due to Haberman's aggressive behaviors and racially motivated statements, all paperwork was conducted in the patrol vehicle to avoid a physical altercation with Haberman.

While I was completing necessary paperwork, Haberman willfully made multiple racially motivated statements and threats towards PFC Tappin and I. Haberman said, "Take your vest off and let's step outside, come on, let me out so I can catch a real battery charge." Based on these statements and threats, and the totality of


