Brodigan pointed to his heavily damaged blue Ford Escape bearing FL tag IK44NF, and stated that he was coming home from an event in North Palm Beach and "did that" on his way home. While trying to conduct a fact finding investigation as to how the vehicle sustained the damage, I observed Brodigan talking in a very slow and slurred speech, as well as observing him losing his balance and almost falling over several times. Based upon my observations at the time and his story not making logical sense, I requested a DUI investigator to respond to the scene. PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On April 11th, 2026, at approximately 00:52 hours, I responded to a single vehicle crash in involving a suspected impaired driver. The incident took place in the area of Okeechobee Blvd and Turnpike exit ramp. I arrived on scene and observed two marked patrol cars with emergency light activated in the eastbound lanes. I observed a blue Ford (FL Tag: IK44NF) with heavy front right damage and right rear damage. I observed a white male wearing a striped shirt and khaki pants sitting on the curb. I met and spoke with D/S N. Destefano ID#47241, who advised me of the incident and signs of impairment. He obtained a sworn recorded witness statement from the caller/complainant, Christopher Harvey. Sworn statement was captured on his body worn camera. Please see supplemental probable cause affidavit.

OBSERVATION OF DRIVER:

Upon making contact with the driver, who was identified by his Florida driver's license as Charles Thomas Brodigan, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from his person and face area. Brodigan's appearance appeared sluggish and disheveled. His pants were dirty. He could not tell me what happened or what he collided with. He had trouble remembering his address. As he spoke, his words were slurred, slow, and thick. The odor intensified as he spoke to me. He had an unsteady gate while walking to my patrol vehicle and had difficulties following directions. His eyes were red, glassy, and watery.

DRIVER'S STATEMENTS:

On scene, Brodigan advised he was coming from a date.

Brodigan refused breath and after implied consent was read and explained, he advised he understood. He consented to breath.

Brodigan invoked his rights to counsel and Q&A was not conducted.

ODORS:

Odor of unknown alcoholic beverage coming from his breath and intensified as he spoke to me.

GENERAL OBSERVATIONS

SPEECH: Slurred, Thick, and slow.

ATTITUDE: Indifferent, confused, calm, cooperative.

CLOTHING: White shirt, khaki pants, brown shoes

MEDICAL/OTHER: Brodigan advised he had no medical conditions

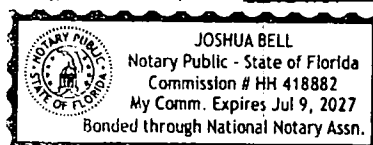

Brodigan swayed in a side to side manner.

WALK & TURN:

I explained and demonstrated the Walk and Turn Task to Brodigan, whom advised he understood. During the instructional stage, he started before being asked to do so. During the task, he did not step heel to toe. He did not take the correct number of steps. He performed an improper turn other than what was demonstrated. He stepped off the line and did not count his steps out loud as instructed. He swayed in a side to side manner.

ONE LEG STAND:

I explained and demonstrated the One Leg Stand Task to Brodigan, who advised he understood. He lost his balance and almost fell over. He advised he could not balance. He held onto my arm for balance. He bent his knee and did not count as instructed. He placed his foot down several times. Task was not completed due to Brodigan's safety.

FINGER TO NOSE:

I explained and demonstrated the Hand Coordination Task to Bieneman, whom advised he understood. He swayed in a side to side manner. He missed the tip of his nose and he used incorrect hand.

ROMBERG ALPHABET:

I explained and demonstrated the Romberg Alphabet Task to Brodigan, whom advised he understood. He did not recite the alphabet correctly. He did not keep his head tilted back. He swayed in a side to side manner.

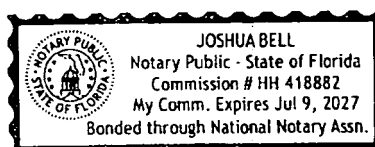
