<p>On February 5, 2024, at approximately 0016 hours, Ofc. Howard observed a white Toyota bearing FL tag#54ABZQ traveling at a high rate of speed northbound on S Dixie Hwy towards Belvedere Rd. Ofc. Howard initiated a traffic stop and observed a white male, who was identified via FL DL as Joseph E. Davis (W/M 5/5/1969), as the sole occupant and driver of the vehicle. Ofc. Howard said the driver had an unknown alcoholic beverage emitting from his breath. See Ofc. Howards supplemental report for further.</p>	

<b>Observation of Driver</b>
<p>Upon arrival, I made contact with the driver (Davis) and I immediately smelled an unknown alcoholic beverage emitting from his breath as he spoke to me.</p>

<b>Drivers Statements:</b>
<p>Davis said he had been drinking in two locations in the area of West Palm Beach, one of which he said was Hullahaloo located at 517 Clematis St. WPB, FL and the other was Sneakers Bar located at 331 N Dixie Hwy. Davis said he had one glass of vodka at each location, but he was unsure of the exact amount</p> <p>Davis said he had no medical condition that he was aware of that could hinder the exercise. Davis said he would be willing to conduct the Field Sobriety Test (SFST' s).</p>

<b>Odors:</b>
<p>I could smell an unknown alcoholic beverage emitting from his breath.</p>

Prior to checking for the exercise clues, I checked Davis's eyes for equal pupil size, resting nystagmus, and equal tracking. Davis had equal pupil size, resting nystagmus, and his eyes tracked equally. During the HGN exercise (horizontal gaze nystagmus), I told Davis to follow the tip of my finger with his eyes only. I observed the lack of smooth pursuit on each eye and distinct and sustained nystagmus in each eye. Davis also had nystagmus prior to 45 on either eye, however, he did not have vertical nystagmus on each eye. During the exercise Davis was asked multiple times to refrain from using his head when following my finger. Davis said he understood but continued to move his head during the exercise.

### Walk and Turn Task

During the walk and turn exercise, I had Davis get into the instructional position for the exercise. After I had Davis get into the instructional position, I gave him the instructions for the exercise. I asked Davis to place his left foot in front of his right foot on the white line that was on the road with his hands on his sides. I instructed him when told to do so, to take 9 heels to toe steps, on the last step take small series of steps to turn around and continue until he got to where he started, all while counting the steps out loud. I demonstrated the exercises for him. Davis said he understood and began the exercise. On his fourth step, he lost balance and stepped out of the line. Davis failed to maintain balance throughout the exercise. Davis failed to maintain his hands on his side by lifting his arms throughout the exercise, however he was able to count his steps out loud. On his steps back, Davis stepped out of the line a second time, losing his balance. It should be noted that the area we were in was clear from debris.

### One Leg Stand

During the one leg stand, I asked Davis to stand with his feet together and with his arms down at his sides. During this time, Davis placed his arms behind his back and was reminded to place them down his sides. After, I had Davis get into the instructional position while I gave him instructions for the exercise. Davis was instructed to raise a foot (either foot) approximately six inches off the ground and parallel to the ground. Davis was also instructed to look at the raised foot all while counting out loud in the following manner, "one thousand one, one thousand two" etc. until told to stop. I told Davis not to start until told to do so. While conducting the evaluation, Davis began the exercise without being told to begin. Davis used his arms for balance by raising them more than six inches from his side. He was also swaying during the exercise. Davis failed to keep his foot approximately six inches from the ground and kept his foot closer to the ground throughout the exercise. Davis counted in the following manner, "one one thousand, two one thousand, three one thousand, etc." which was not how it was instructed. Davis placed his foot on the ground and lost balance. He asked to repeat the exercise and he repeated the same until he said he no longer wanted to do this exercise.

### Finger To Nose

I told Davis to stand with his feet together and his arms by his side. I asked Davis if he knew his right from his left and he demonstrated he did. Davis got in the instructional position, and I gave him the instructions for the exercise. I then demonstrated the exercise for him. I told Davis when I call out his right or left hand to place the tip of his finger to the tip of his nose. I asked Davis if he understood, and he stated he did. I also instructed Davis to tilt his head back with his eyes closed. Davis was instructed to make a fist with his hands and to have his index finger pointed out and to keep his arms to his side. During the evaluation, missed his nose each time and he had a slight sway to his body. However, Davis did keep his head tilted back with his eyes closed the entire time.

### Romberg Balance

I told Davis to stand with his feet together and his arms by his side. I told Davis when I instructed him to, I wanted him to tilt his head back and close his eyes. I told Davis I wanted him to approximate thirty seconds in his head. I told Davis when he finished to look at me and tell me he was done. I asked Davis if he understood those instructions and he stated he did. While conducting the evaluation Davis had a slight sway. Davis did keep his head tilted back with his eyes closed. Davis stopped at approximately 15 seconds.
