This is a summary of the facts as stated in the affidavit of the undersigned.

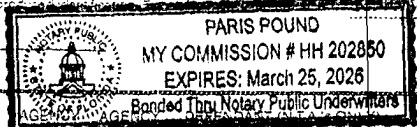
**On Sunday, May 5, 2024 at approximately 0058 hours, while patrolling eastbound on Southern Boulevard, approaching Lion Country Road, Loxahatchee (Palm Beach County) Florida, I observed a vehicle with one head light out traveling westbound in the inside lane at a high rate of speed. The vehicle was traveling in the inside lane and passing another westbound vehicle. I visually estimated its speed to be in excess of 100 miles per hour in a posted 55 mph speed zone. The vehicle passed me and I made a U-turn to overtake it. After turning around I increased my speed to over 100 mph in an effort to catch up to it. The vehicle continued traveling at a high rate of speed. I saw its brake lights illuminate as it entered into the U-turn only lane at the intersection of Arden Lake Ave. I watched it make the U-turn and began traveling back east. It once again increased its speed to over 100 mph as I did the same to catch up to it. I watched it weave over the broken lines that separate the lanes. We reached the intersection of Lion Country Rd where it came to a stop at the traffic light. I called the tag in to "dispatch" and activated my emergency lights to conduct a traffic stop on it. The vehicle pulled over to the east shoulder of the roadway and came to a stop with its rear side partially in the roadway. The driver side door opened and a white female began stepping out of the driver side. She stated she was the only person inside the vehicle. Deputy Tifani Liming responded to my location for back up. Meanwhile I began conversing with the driver, who was later identified as Charlotte Ann Rolon by her Florida driver license. I noticed her eyes were red, watery and glossy. Her face was flushed, mouth dry and she was talkative. She labored in maintaining her balance and swayed throughout my encounter with her. I could smell a strong odor of an unknown alcoholic beverage emanating from her breath that intensified as she spoke. She was wearing blue dress. I told her she was traveling in excess of 100 mph in a posted 55 mph zone. She [redacted] and said she had taken a friend home. I told her I had a suspicion she had drank an unspecified amount of alcoholic beverages. She told me she had not drank anything. She later [redacted] Based on my suspicion I asked if she would perform Standardized Field Sobriety Tests to determined if she was impaired while operating her vehicle. She obliged.**

I am a Notary Public in and for the State of Florida, Commission # \_\_\_\_\_, expires on \_\_\_\_\_.

Prior to her performance I asked if she had any physical issues with her body. I also asked if she was taking medication. She told me she is not medicated, but has anxiety issues. I escorted her to a level surface that was smooth and free from any obstruction and debris. This area was well illuminated by the headlights on my patrol vehicle. I placed a yellow strip of tape on the surface that formed a line. The defendant identified the tape by announcing its color and placing her left foot on it when prompted to do so. The following tasks were explained, demonstrated and acknowledged by her prior to her performance: HGN, THE WALK AND TURN, ONE LEG STAND, FINGER TO NOSE AND THE ROMBERG ALPHABET RECITATION. Her deficiencies were recorded on another form on this work packet. At the conclusion of the tasks, coupled with my observation of the defendant's vehicle in motion and my observation of personal indicators of impairment exhibited by the defendant, probable cause was established for DUI. I told the defendant she was being placed under lawful arrest for the charge. She was handcuffed (checked for proper fit) prior to being seated into the rear of my patrol vehicle. Priority Towing responded on a rotation request and impounded the defendant's vehicle to their lot. Meanwhile I began transport to the Publix's parking lot, located at 15625 Southern Bv., to meet with the Mobile BAT for further processing. Upon our arrival I began a 20 minute observation period. The defendant was slipping the handcuffs and placing her hands in front. I asked her not to remove the handcuffs. She once again slipped the handcuffs. I placed them in the back again and told the technician to restart the 20 minute observation. During this time the defendant did not ingest anything into her body orally or otherwise. Neither did she regurgitate. Afterward I escorted her into the Mobile BAT and asked her to provide breath samples for the purpose of detecting her alcohol content. She remained quiet and would not answer my questions. She refused to provide breath samples and was read implied consent. She told me she did not understand the "consent". I allowed her to read the text for herself, but she said she did not understand. I simplified the meaning of the it and she said it sounded Chinese. I do believe she understood the consent and was unwilling to provide breath samples. Thus I deemed her a refusal. No Q&A was performed. The defendant was booked into the west county jail for DUI.

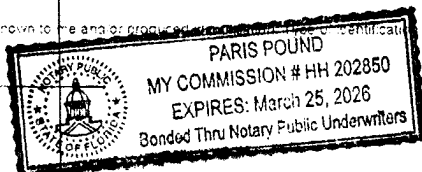

**Other Observations:**

Defendant was asked to stand erect with their feet together. They were told to remain in this position until the task was completed. They were asked to identify the stimulus that was held in front of their face. Afterward they were asked to follow the stimulus with their eyes and not to turn their head. They understood the instructions. The defendant showed equal pupil size and had no resting Nystagmus. During the tasks the defendant lacked smooth pursuit in both eyes. I saw distinct and sustained Nystagmus in both eyes. I saw an onset of Nystagmus prior to 45 degrees in both eyes. The defendant turned their head to assist in following the stimulus. Defendant had to be reminded not to turn their head and keep their feet together. The defendant swayed while performing this task.

**WALK & TURN:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE WALK AND TURN. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject was unable to maintain their balance while placed in the instructional position (feet separated as they lost their balance). During the walking phase subject missed heel to toe, stepped off line, stopped on line to steady, asked for additional instructions, did not complete this task as instructed, walked backwards back down the line

**ONE LEG STAND:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE ONE LEG STAND. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject put foot down, Sways

**FINGER TO NOSE:**

THE DEFENDANT WAS PLACED IN THE INSTRUCTIONAL STANCE FOR THE FINGER TO NOSE. THIS TASK WAS EXPLAINED AND DEMONSTRATED TO THE DEFENDANT. THE DEFENDANT ACKNOWLEDGED THE INSTRUCTIONS PRIOR TO PERFORMING THIS TASK: Subject swayed and could not maintain balance while standing, failed to touch the tip of finger to the tip of nose on all attempts as instructed, rather touched underneath and sides of nose with the pad of finger.

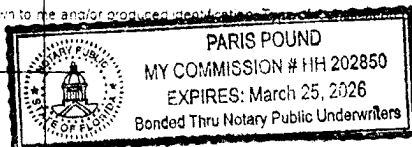




