The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. The Person taken into custody... [X] committed the below acts in my presence. [X] was found to have committed the below acts, resulting from my (described) investigation.

Victim has invoked Marsy's Law Rights
On 11/01/2023 at approximately 0154 hours, I was conducting routine security patrol at 187 SE Mizner Blvd (The Standard) when I observed two white males begin to physically fight. I observed one white male with brown hair and a red shirt began to strike another white male wearing an orange Halloween costume in the face multiple times with his left closed fist. At this point, I gave a verbal command to "get off him" and directed the white male with the red shirt off the other male, who was now on the ground and bleeding from his face excessively. The white male with the red shirt was detained in handcuffs and placed into Ofc. J. Cox's vehicle. I then spoke with the male in the orange Halloween costume, who was identified by his FL DL to be [Redacted]. I requested BRFD assistance as the male had lots of bleeding coming from his nose onto his shirt and arms. BRFD arrived, but [Redacted] did not wish to go to the hospital. I then obtained a sworn victim statement from [Redacted] on my MVR body camera. According to [Redacted], he had gotten into a verbal argument with the other white male with brown hair (whom he did not know), and he got punched in the face. He did not remember how it began, however, he did not attempt to defend himself or fight back because he knew it would be wrong. [Redacted] completed a Marsy's Law form. I captured photos of [Redacted]'s face on my MVR body camera. I then spoke with the other party involved (white male with brown hair and red shirt), who was identified by his NY DL to be Chase Laganas. I read Laganas his Constitutional Warnings from a preprinted card issued by BRPD. Laganas advised he understood and stated he would tell me the truth. According to Laganas, he got upset after the other male involved ([Redacted]) had called his sister a "whore" multiple times. While walking outside
