

On Sunday, May 10, 2026 at 1942hrs, I, Officer Smigelski responded to the area of PGA Blvd and Interstate 95, Palm Beach Gardens, FL 33410. This was in reference to a possible impaired driver. My department issued body worn camera was utilized during this investigation.

Prior to my arrival, Ofc. Borgela (ID 534) was conducting routine patrol operations in the area of PGA Blvd and Interstate 95. Ofc. Borgela observed a white 2016 Chevy Malibu (FL tag 03ADLK) traveling westbound on PGA Blvd, when suddenly it performed an illegal u-turn at the intersection of PGA Blvd and Interstate 95. The vehicle then began traveling eastbound on PGA Blvd, it was then that Ofc. Borgela initiated a traffic stop. Upon making contact with the driver, Chelsea Bakker (DOB 8/19/1989), who was identified by her Florida driver's license. She stated that she was traveling from the Ross department store and was on her way home. Ofc. Borgela observed Bakker to have slurred speech, red watery eyes and a strong odor of alcohol. See his supplemental report for further.

Upon my arrival, I made contact with Bakker who was located behind the wheel in the front driver's seat. There was also a passenger in the front passenger seat who was identified as, Heather Haag (DOB 5/18/1985). Bakker stated to me that she was traveling from Ross and prior to that she was at her residence. Bakker stated that she had not consumed any alcohol or narcotics prior to operating her vehicle. I observed Bakker to have red watery eyes, slurred speech and an odor of alcohol. Due to these indicators, I requested that Bakker complete a series of standardized field side sobriety exercises, to which she complied.

The first exercise was testing for Horizontal Gauze Nystagmus and the stimulus used was a pen with an illuminated red tip. Upon completing the instructions, Bakker stated that she understood the instructions. While checking for lack of smooth pursuit, Bakker



exhibited a lack of smooth pursuit in both eyes. When checking for maximum deviation and prior to 45 degrees offset, Bakker exhibited six indicators total. When testing for Vertical Gauze Nystagmus, she exhibited definite indicators. Bakker was also observed swaying side to side throughout the exercise. Bakker also had to be reminded to not move her head during the exercise.

The second exercise was the walk and turn, with yellow tape as the stimulus. During the instruction portion, Bakker was observed to have difficulty maintaining the starting position. After completing the instructions, Bakker stated that he understood the instructions and began the exercise. Upon beginning the exercise, I observed Bakker to have stepping off the line and missing heel to toe during her first nine steps. I also observed her raising her arms in order to maintain balance. During the turn portion, Bakker performed an improper turn, turning in place on her initial ninth step. Upon her return nine steps, Bakker was observed stepping off the line and missing touching heel to toe. She also raised her arms in order to maintain balance.

The third exercise was the one leg stand. Upon completing the instruction portion, Bakker stated that he understood the instructions given to him and he began the exercise. Upon beginning the exercise, Bakker raised her right foot lower than the height that was instructed to her. She then immediately placed her foot on the ground. Upon resuming the exercise, Bakker raised her right foot and held it until the count of twenty without placing it down. During the exercise, Bakker failed to look down at her foot as instructed and had to be repeatedly reminded to look at her foot. Bakker was also observed to be swaying side to side during the exercise.

The fourth exercise was the finger to nose. Upon completing the instruction portion, Bakker stated that he understood the instructions given to him and he began the exercise. When instructed to raise her left hand, Bakker failed to touch the tip of her nose with her left fingertip. She then had to be instructed to lower her left hand. Bakker was then instructed to raise her right hand, to which she touched below the tip of her nose with her right fingertip. Bakker had to be instructed to lower her right hand. She was then instructed to raise her left hand. Bakker failed to touch the tip of her nose with her left fingertip and had to be instructed to lower her left hand. During this portion of the exercise, Bakker dropped her head and had to be instructed to tilt her head back as instructed. When instructed to raise her right hand, Bakker failed to touch the tip of her nose with her right fingertip. She then had to be instructed to drop her right hand. Bakker was then instructed to raise her right hand again, Bakker flinched her left hand, then raised her right hand. Bakker failed to touch the tip of her nose with her right fingertip and had to be instructed to drop her right hand. She was then instructed to raise her left hand, to which Bakker failed to touch the tip of her nose with her left fingertip and had to be instructed to lower her left hand.

Based on my observations and the totality of the circumstances to this point, I placed




Bakker under arrest at 2005hrs. At the PBSO BAT I conducted a 20-minute observation period of Bakker noting no issues. I requested Bakker to provide a breath sample for the purpose of determining its alcohol content, to which she complied initially, then prior to beginning the test she refused. It was then I informed Bakker of Implied Consent at 2122hrs, to which she refused.

Based on the events of my investigation and the totality of the circumstances, I find probable cause to charge Chelsea Ann Bakker with Driving under the Influence Normal Faculties Impaired F.S.S. 316.193(1) (A), and Driving Under the Influence Refusal to Submit to DUI Testing F.S.S. 316.1939(1) (E).
