On Friday, February 24th, 2024 at approximately 2359 hrs I observed a Gray Kia SUV bearing Florida License Plate 77ELYC traveling north bound on US Hwy 441 at an extremely high rate of speed approaching the intersection of Pierson Rd. I proceeded to attempt to catch up to the vehicle which was steady pulling away from my marked patrol vehicle. I estimated the vehicle's speed to be in excess of approximately 100 mph or more, therefore i began to slow down as it appeared I would not be able to catch up the vehicle.

I observed the vehicle swerve from the outside number 1 lane of travel to the outside number 4 lane of travel before coming to a stop just over the white solid line t the intersection for a red traffic signal. At this time I caught up to the vehicle and initiated a traffic stop on the Kia SUV which slowly moved to the right onto the right shoulder coming to a rolling stop.

I made contact with the driver at the driver's side window where I observed her to have a moderate odor of an unknown alcoholic beverage emanating from her head and shoulder area. I inquired with the driver if she had consumed any alcohol to which she replied yes a glass of wine approximately an 1 hour earlier. I requested the driver's license, registration, and proof of insurance. She provided her Florida Driver's License which had her photograph affixed and identified her as Christina Laboy (Date of birth 09/17/1978).

I requested the driver perform field sobriety exercises which she did based on my observations of the driver there was not enough probable cause to place her under lawful arrest for DUI therefore I advised her to contact someone to respond to the scene to retrieve her and her vehicle. Laboy contacted her son and a male subject later identified as Ryan both of whom advised that they would respond to the scene to pick her up.

While standing by with Laboy awaiting her son identified as Juan R. Laboy (date of birth 09/28/06) to arrive Laboy became belligerent and argumentative accusing Law Enforcement of stopping her because she was white. Laboy continued to rant D/S J. Hasting I.D. 43372 attempted to calm Laboy who became irate toward her as she continued to rant and yell Laboy stated to hasting "I'll Fuck you up!" and step toward Hasting at this time due to her statement I took Laboy into custody as there was probable cause for her arrest for corruption by threat and assault on a law enforcement officer based on her threat to fuck D/S Hasting up and her stepping toward her there was probable cause for her arrest.

Laboy struggled as I attempted to handcuff her and attempted to pull away at which time I pinned her against the rear of my marked patrol vehicle and secured her in handcuffs with D/S Hasting assistance. D/S Hasting attempted to conduct a pat search of Laboy who continued to pull away stating "don't let that bitch touch me".

I escorted Laboy to the rear of my marked patrol vehicle where she continued to struggle and fight with D/S Hasting and I and refused to be seated in the marked patrol vehicle. Laboy had to be pushed into the marked patrol vehicle where she began kick and fight with Deputies during the course of her struggle she intentionally kick my right hand causing a laceration and abrasion to my right hand, D/S Hasting and I informed Laboy to stop kicks several times however she continued to do so. based on Laboy's behavior there was probable cause for her arrest for battery on a Law Enforcement Officer and resisting arrest with violence contrary to F.S.S.
