The following incident occurred in the City of Delray Beach, Palm Beach County, Florida. On 12/01/23 at approximately 1007 hours, Community Service Officer Johnson Hazel responded to the intersection of S Military Trail and Jefferson Rd in reference to a hit and run crash. Upon arrival CSO Johnson Hazel made contact with Nikki Thorn who was the driver of the 2020 Buick Encore. Thorn advised that she was traveling south in the left lane. As she approached the intersection of S Military Trail and Jefferson Rd, a white Tesla proceeded to make a U-turn and struck the left side of her vehicle. The impact caused her vehicle to veer to its right, where the vehicle struck and jumped the curb before coming to its final rest on the sidewalk. After the impact the suspect vehicle continued to travel south where it was last seen making a right turn into the Gramercy Square Development. Thorn described the suspect driver as a white "sun tanned" color female, thin build, approximately mid 20's - early 30's in age. A bicyclist, Bart Galletta who was in the area advised he saw the tail end of the impact. After the impact, the suspect who was later identified as Christine Saad Abad, exited her vehicle, looked at the damage to her vehicle, and then fled the scene. Galletta observed the suspect vehicle turn into the Gramercy Square Development. Galletta made contact with a board member of the HOA and was able to obtain video of the suspect vehicle which sustained front end damage from the crash entering the community. Galletta was able to provide the suspect vehicle's License Plate Number NKKT25. 12/6/23 Bart Galletta responded to the Delray Beach Department and was presented with a Photo Lineup consisting of 6 photos. Galletta was able positively identify Christine Saad Abad as the driver of the suspect vehicle. On 12/11/23 I responded to Galletta's residence and obtained a sworn statement which was captured on my BWC.
