Further investigation into the welfare checks Mr. Jeffers calls into dispatch versus what Mr. Jeffers texts Mrs. Prange are in complete contradiction of each other. Mrs. Prange complied text messages that coincide with the calls of service where Mr. Jeffers does not get his way with a video phone call and uses Law Enforcement to harass Mrs. Prange by showing up at her home and place of work. Mrs. Prange also said Mr. Jeffers is using Law Enforcement as a sort of spying tool to try and obtain more information on their whereabouts, who is with them, etc. Mrs. Prange said on several occasions Mr. Jeffers told her on the phone several times that because of these welfare checks he knows where she is and he is going to kill her and her family.

Mrs. Prange was clearly in fear for her life as just talking about the incident made her cry and tremble. Mrs. Prange said besides the welfare checks Mr. Jeffers calls in, he also calls her place of work and tries to get her fired by telling her boss that she's a terrible person who mistreats Dallas etc. Mrs. Prange said luckily her boss understands the situation she's in but is still embarrassed that she has to go through this.

Mrs. Prange showed numerous pieces of evidence to include text messages and reports from other law enforcement agencies that show an excessive course of conduct Mr. Jeffers is involved in where he uses the means of Law Enforcement to harass her. Mr. Jeffers falsifies welfare checks in an attempt to intimidate, stalk, and harass Mrs. Prange which has caused substantial emotional distress to Mrs. Prange and serves no legitimate purpose. Further, Mrs. Prange said Mr. Jeffers has threatened to kill her and her family numerous times over the phone which has caused her to live in fear for not knowing if and when he will make promise on his threat.

I later attempted to speak with Mr. Jeffers on the phone but was unsuccessful.

All of the text messages and other agency reports were submitted into evidence.com

Based on my investigation I determined Mr. Jeffers violated FSS 784.048(2) for stalking for over the span of November 27th, 2024 to current has been falsely using Law Enforcement to conduct welfare checks on Mrs. Prange's residence and place of work to serve no legitimate purpose other than to harass, intimidate, and obtain information in which he uses to stalk and threaten to kill her and her family. This continuous course of conduct has caused Mrs. Prange substantial emotional distress. Because Mrs. Prange and Mr. Jeffers have a child in common I also find this stalking charge falls under the domestic violence enhancement.
