The vehicle continued west and as it approached Old Crestwood Blvd, the truck slowed and drove across the marked crosswalk and up the sidewalk on the north side of the road. The vehicle backed up a couple of times trying to turn north in the southbound lanes of Old Crestwood Blvd. I activated the emergency lights of my marked patrol vehicle and as I exited my vehicle, I gave verbal commands to "stop". The driver stopped facing northwest just east of the sidewalk.</p> <p>I approached the passenger side and contacted contact with the sole occupant, Christopher Schwartzwaldler. He immediately provided me with his Florida driver license and vehicle's registration and insurance. While on the passenger side of the vehicle, I could smell an odor of an unknown alcoholic beverage coming from inside the vehicle. I then contacted Inv. Pointu #16032 to respond to the scene to conduct a DUI investigation.</p> <p>I then reapproached the vehicle on the driver's side, speaking with Schwartzwaldler. He stated that he was 1000' feet from his house on Collecting Canal Rd, which is approximately 4 miles west of our location.</p> <p>The scene was turned over to Inv. D/S Miller observed a white Chevrolet Silverado bearing Florida IX92WQ driving westbound on State Road 80 west of Cypress Head Ave, in the Village of Royal Palm Beach, Palm Beach County, Florida. The truck approached the entrance to the Cypress Key neighborhood and swerved right into the bicycle lane then corrected back. The vehicle continued westbound and as it approached Old Crestwood Blvd, slowed down and drove across the marked crosswalk and up the sidewalk on the north side of the road. The vehicle then backed up a couple of times trying to turn north in the southbound lanes of Old Crestwood Blvd. The driver and only occupant was identified by his Florida driver license as Christopher Schwartzwalder.

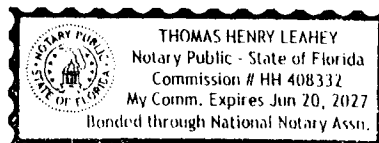

WALK & TURN:

Schwartzwalder could not maintain the instructional stand and he started to walk before being told. Once asked to start he did not walk heel to toe on every steps. He used his arms to balance. He stopped to ask for instruction and did not turn as instructed. He then walked back, again not touching heel to toe and using his arms to balance.

ONE LEG STAND:

Schwartzwalder raised his right leg. He swayed while balancing, hopped and put his foot down multiple times. He also omitted to use the thousand while counting some of the time.

FINGER TO NOSE:

Schwartzwalder used the pad of his finger on all tasks instead of the tip. On task 1 he had to be reminded to lower his hand. On tasks 6 he touched the left side of nose. He swayed during the task.

ROMBERG ALPHABET:

Schwartzwalder recited the alphabet properly but swayed during the task. He also opened his eyes. For the Romberg balance, Schwartzwalder did not stop the task. When I asked him what was the instruction he told me to stay with his eyes closed and wait.

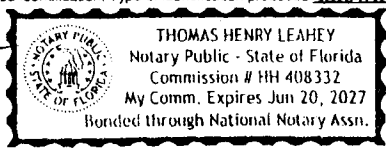

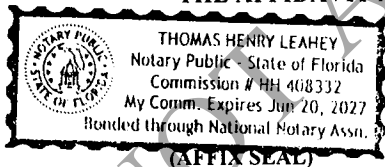
