The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 10/4/2025, at 0339 hours, I observed a white Kia bearing FL tag: 60BJWV (VIN: KNDEU2AA6N7317325) traveling eastbound on W Brandon Blvd. I conducted a traffic stop on the white Kia for a welfare check/Failure to maintain a single lane. The defendant was the sole occupant of the vehicle. I made contact with the defendant and observed her to have signs of impairment, such as a strong odor of an alcoholic beverage emanating from her breath every time she talked, and glassy/water eyes. I requested the defendant perform Standard Field Sobriety Exercises (SFSEs), which she refused to do. The defendant was then arrested for DUI based on the totality of the circumstances. I transported the defendant to Central Breath Testing (CBT). Once at CBT, the defendant refused to provide a lawful breath sample to determine her breath alcohol content (BrAC) after being advised of the Implied Consent Warning and understanding. The defendant was positively identified via passport and charged with a DUI BrAC Refusal.
